THE PROS AND CONS MEASURE U -

On April 8th, voters in Sierra Madre will decide the fate of Measure U - the UTILITY USER'S TAX EXTENSION. This article is presenting the language of the ballot measure and the language, Pro and Con, unedited, of the ballot statements.

The Measure:

To maintain City Services, such as Public Safety, Paramedic and Library services, shall an Ordinance be adopted to:

1. Extend the City's current 10% Utility User Tax at a maximum of 10% for all utilities except water and sewer;

2. Establish new sunset dates starting July 1, 2022;

3. Extend the current 9% water and sewer tax until July 1, 2014 when it will reduce to 7%, and then 6% on July 1, 2015?

4. YES or NO

THE ARGUMENT AGAINST MEASURE UUT
Vote NO on Measure UUT -

The tax increase is not necessary to maintain current revenue or service levels in the City thanks to existing revenue increases already built in. Authors of this User Utility Tax (UUT) increase measure will tell that you more tax money is needed. This is clearly false given that the city finished the 2013-2013 fiscal year with over \$870,000.00 in unassigned General Fund reserves.

Property tax revenue (income) continues to increase. In the 6 months ending December 15, 2013, over 80 properties sold in Sierra Madre. Conservatively, the resulting estimated increase in property tax income will be an additional \$50,000.00 per YEAR. Property tax income will also continue to increase as more homes sell for higher prices. Income from the current UUT Law continues to increase as utility bills continue to go up. With large water rate increases scheduled for February and July 2014, the city will collect MORE monthly income at the (continued on page 5)

TRASH AND BURN
CAMPAIGN HEATS UP IN
SIERRA MADRE

Sierra Madre is a town known for its diversity of opinions and often high level of emotions during political campaigns. Sierra Madre attracted what most have called unwanted attention to this town and have had some rather colorful descriptions assigned to us by outside media outlets.

With the final weeks of the Municipal election fast approaching, it appears the “Wistaria Hysteria” has dropped to a new low. Earlier this week, resident John Crawford, who is responsible for the controversial Tattler blog in Sierra Madre, posted personal pictures of city council candidate Noah Green and proceeded to use them to declare Green unelectable.

The photos are from the Greens 2011 vacation, which according to Green and his wife Melanie, were taken shortly after their marriage. “When we took those, we just got married.” “We were in a happy, playful phase.” “We were both on vacation and having fun. “This is very frustrating”, are quotes from Mrs. Green published in Wednesday’s Pasadena Star News.

If the pictures were to be rated by “today’s standards they would not be rated X, R or possibly not even PG”, said one industry professional who looked at Crawford’s blog.

What has elicited the most critical response is the manner in which they were obtained and posted. Crawford states that the photos were sent to him by a blog reader. They were initially posted on Melanie Green’s private Facebook page and, because she identified (or tagged) her husband, they appeared on Green’s Facebook page, which is public. Allegedly, they were then sent to Crawford. In any event, neither Noah nor Melanie Green authorized the publishing of the photos on the blog.

In this day and age, social media sites are considered as personal as the old-fashioned family album with the expectation that only invited family and friends will share the photos. Nevertheless, “none of the photos depict anything illegal, perverse or immoral”, said another viewer who spoke with the Mountain Views News.

In the Star News article, the author reports that the blog post had generated “more than 100 comments.” However, based on Crawford’s

admitted use of the internet activity known as ‘Trolling’, the actual number of comments about the pictures is questionable.

In January 2013, Crawford, using pen name, Sir Eric Maundry, sent the following message to Councilman Chris Koerber regarding the Community Redevelopment Agency Successor Committee: Said Crawford, “Here is this week’s troll strategy”, revealing how he manipulates the comments on his blog.

When a site is ‘trolled’, comments are posted either anonymously or with names that otherwise conceal the identity of the person posting. The comments are designed to generate heated discussions (in the case of the referenced troll, hateful discussions) and lead others posting on the site to believe that they are chatting with another reader. In fact, most trolling is done by, or with the approval of the moderator.

In Crawford’s email regarding his ‘troll of the week’, the comment is: “when are we going to go over to that dump he lives in on Baldwin with torches, tar and feathers...” (See copy of complete message on page 5). It is believed that the troll is referring to the home of Former Sierra Madre Mayor Bart Doyle, the only member of the CRA successor committee that lives on North Baldwin, and a frequent object of personal attacks by Crawford on the blog. The Mountain Views News discovered this information in May, 2013 while researching a story on Bob Matheson, the resident convicted of possession of child pornography in Canada.

Described as an internet practice which, according to Paul Gill of About.com, “... is the anti-social act of causing interpersonal conflict and shock-value controversy online. Named for the wicked troll creatures of children’s tales, trolling is purposely sowing hatred, bigotry, racism, misogyny, or just simple bickering between others. Trolls themselves are emotionally-immature users who thrive in any environment where they are allowed to make public comments, like blog sites, news sites, discussion forums, and game chat.”

Wikipedia notes that media attention in recent years has equated trolling with online harassment. For example, (continued on page 5)

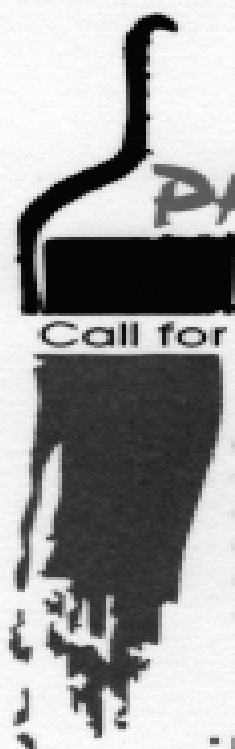

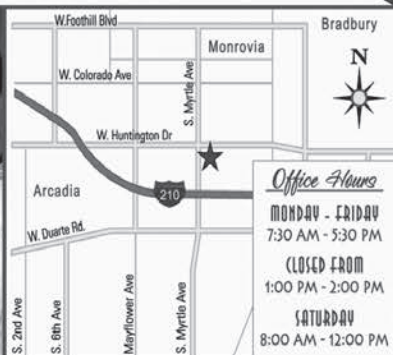

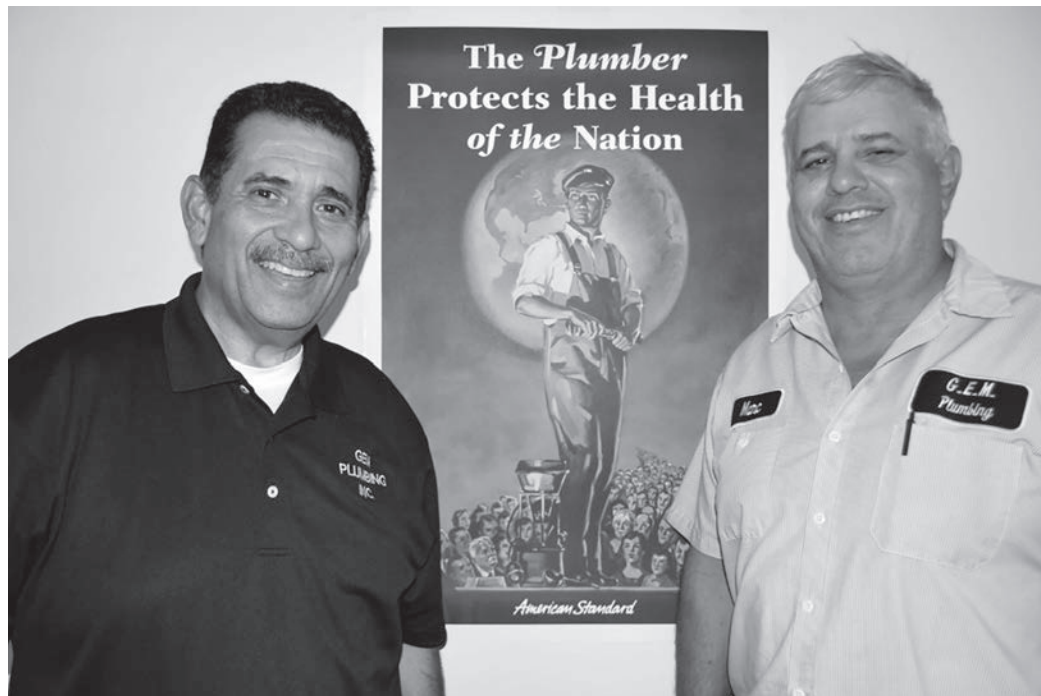

Here's something I bet you didn't know: Sierra Madre's own G.E.M. Plumbing has one of the oldest contracting licenses in the entire State of California! Their license number is 111308 and contractor's license numbers are now in the 900,000's! Of course, theirs was issued in 1949 and you just don't run into many plumbing contractors who have been in business for 65 years! Had a great time chatting with the guys who are the heart and soul of G.E.M. Plumbing: Dave Pedroza, the main plumbing guy; and Marc Van Cleave, the A/C-Heating expert. Dave and Marc are celebrating their 20th G.E.M. anniversary, can you believe it!

The original Sierra Madre G.E.M. guy, Gordon Caldwell, is turning 90 later this month. You still see Gordon 'round about town, he's active in Kiwanis, as are Marc and Dave. In fact, start planning to attend the Kiwanis Pancake Breakfast on Saturday, February 22nd to kick off the Little League season. Guys, we love the pancake breakfast, best pancakes anywhere!

Here's something else I certainly didn't know: G.E.M. was originally started around 1944-45 by Gordon Earl Moyer, who worked out of the Thousand Oaks area, concentrating on new constructions. Hal Jordan partnered with Gordon Earl Moyer in 1956 and in 1958, Hal and Gordon Caldwell became partners and brought G.E.M. to Sierra Madre. G.E.M. was located for ten years on South Baldwin by the Post Office, moving in 1968 to North Baldwin, where Beantown is now, moving into their present location on Montecito in 1988. That Montecito neighborhood right around G.E.M. is getting to be more and more interesting as it transitions from small bungalows to mixed property use. Really like those half residence-half business condos. Of course, we've got The Shabby Dog, pet groomers; Red Door Antiques; and Ixora, the floral headquarters of Lisa and Craig Cardella. So much going on on Montecito, east of Baldwin! Great place to walk!

Anyway! Dave had been working as Gordon and Hal's #1 plumbing guy and Marc was the #1 Heating and A/C guy for about eight years before Gordon decided he'd wrestled just about enough leaky pipes to last him a lifetime and he wanted to sell the business and retire. The deal was seconds from completion with Merry Plumbers when, thankfully, it fell through and Gordon offered G.E.M. to Dave and Marc, who really wanted G.E.M. to continue to be a Sierra Madre business. Marc still spends most of his time in the field and you all need to know he's got a special coming up in April for A/C maintenance. The last thing you want to have happen is to flip that switch on the first 95 degree day and have nothing happen! March is also water heater safety month. Just give 'em a call and find out what specials they've got going on.

Marc gets much joy and satisfaction from visiting with customers as he works through whatever's gone wrong with their A/C-heating, leaving happy people behind, who don't hesitate to call G.E.M. as they know they'll get fast and reliable response. As he says, "in a small town like ours, it pays to take time, to take care."

Dave is pretty much the inside guy now, directing their 14 employees and keeping the mountains of paperwork moving. If you've got a business, you can relate to that! That's something else the guys had to learn pretty much right away as Margaret Marsh, who had been Gordon's assistant for 25 years did absolutely all the paper stuff and she retired as Dave and Marc were still trying to figure out what they were doing! But learn they did and succeed they did and now G.E.M. is one of Sierra Madre's most successful businesses. Speaking of employees, past and present, Dave and Marc speak so highly and so appreciatively of all who have been part of G.E.M. They are quick to admit they would never have made it without all these talented folks who have been part of their team.

Gang Member Arrested in Altadena Stabbing

Altadena Deputies arrested a suspected gang member last week after he allegedly stabbed a man five times with a screw driver outside a restaurant near Altadena Drive and Lincoln Avenue. The incident occurred on February 13 at approximately 5:15 p.m.

The suspect, Juan Cortez, approached the victim and his family as they were getting out of their car and became involved in an argument according to police.

Sheriff Deputies said Cortez removed his shirt, exposing a tattoo of "Pasadena" written across his chest. He then announced that he was from a local gang as he tried to punch the victim. The victim was able to duck and knock Cortez to the ground. When Cortez stood up, he attacked the victim with a large screw driver. The victim sustained several puncture wounds and lacerations to his lower back and a small cut on his right arm. The victim did not report the assault and drove himself to Huntington Memorial Hospital.

When detectives spoke to the victim at Huntington Memorial Hospital, they learned a female employee from the nearby restaurant had tried to stop the assault. She had been calling the suspect "Juan". This coupled with the tattoo helped detectives later identify Cortez as the assailant. On February 14, at 6:20 p.m. deputies were able to locate and arrest Cortez after they observed him walking in the city of Pasadena.

This investigation is still on-going. Cortez remains in custody with a bail of \$300,000.00.

Fire Caused by Cigarettes Displaces 19

The parents of two small children dropped them out a two story window Monday night—to neighbors waiting below—before jumping themselves to escape a blaze that caught the steps of an apartment building on fire trapping the family.

Nineteen other residents were displaced in the fire, at 277 Penn Street, first reported at 2:04 a.m. Dalia Esteban and Elmer Rodriguez told reporters they had no choice but to toss their 3 year-old and 4-year-old children out the window.

Pasadena Fire Spokeswoman

Lisa Derderian said the four were transported to a local hospital, with minor arm injuries and leg injuries, as a result of the fall.

The cause of the fire was later determined to be carelessly discarded cigarettes on an old couch placed on an outside balcony.

Derderian said the four-unit building was a total loss and damage was estimated to be \$400,000. Another \$150,000 was losses to the contents.

Derderian said another unrelated house fire in the city

had just broken out less than two hours before the Penn street blaze.

She said a fire broke out in the 1200 block of Rancheros Road near the Rose Bowl around 12:41 a.m. also Monday night. That fire was upgraded to a second-alarm due to the areas narrow streets.

The fire isolated to the wall in the area of a chimney caused \$150,000 in damage. Four adults escaped without injury Derderian said.

Altadena Man Arrested for Assault, Kidnapping

Police say a known Altadena gang member was arrested Wednesday in the 800 block of Euclid Avenue in Pasadena by Detectives from Altadena Sheriff's Station, Pasadena Police Department, and the FBI.

Dennis Mayfield, 32, was wanted for criminal threats and assault of his ex-girlfriend and for holding her against her will. The suspect was considered armed and dangerous due to the fact that he threatened to shoot his ex-girlfriend and was known to carry a handgun. The suspect is also suspected of shooting numerous rounds into the air in the 2000 block of Marengo Avenue on Sunday morning.

Members of the San Gabriel Valley Safe Streets Gang Task Force, which includes Altadena Detectives, Pasadena Police Department Detectives, and FBI agents, started searching for the suspect shortly after the incident was reported and arrested him at the 800 block of Euclid Avenue in Pasadena at approximately 6:00 p.m. They also recovered two firearms inside the suspect's vehicle.

Mayfield was arrested for Kidnapping, Assault with a Deadly Weapon (Firearm), and other Weapons Charges. He was booked at Crescenta Valley Station and is being held on \$1,000,000 bail.

As executive producer of The Alzheimer's Project, Shriver earned two Emmy Awards and an Academy of Television Arts & Sciences award for developing a "television show with a conscience." She has also won Peabody awards in television journalism.

Shriver is also the author of six best-selling books. She is currently a special anchor and correspondent for NBC News.

Community Mourns after Two Murders in Two Days

Less than 48 hours after the city saw the first reported homicide of the year, a second person was gunned down in a drive by shooting that left two other people wounded. Police said the incidences were unrelated.

On Sunday a Pasadena City College student was gunned down by her live-in boyfriend who was later arrested Monday. The Los Angeles County District Attorney's Office formally charged JonJon Crummie Wednesday with two felony criminal counts, homicide and personal and intentional discharge of a firearm causing great bodily injury and death, resulting from the fatal shooting of Crummie's girlfriend, Irais Acosta, 19 Sunday morning. The homicide occurred around 8:48 a.m. in the 1500 block of N. Raymond Avenue.

PCC President Mark Rocha said, "The College extends its deepest sympathy to the Acosta family, friends, and the entire PCC community in this time of loss. Pasadena

City College is a family and this impacts us all. Students, faculty and staff are encouraged to utilize the campus resources available to aid in this time of grief. Counseling services are available through Psychological Services."

Crummie's bail was set at \$2 million. He remains in custody awaiting an arraignment rescheduled twice this week. Acosta death was the first reported homicide of the year according to police.

As of Friday police were still looking for a late-model white SUV involved in a triple shooting Monday night. According to police they responded to a shots fired call in the 1400 block of El Sereno Avenue at about 10 p.m.

Steven Ascencio, 18, of Pasadena died, after what witnesses described as five or six gunshots being fired. A 17-year-old teen and a 19-year-old man were also injured. No other information was given and investigators said the two victims were not cooperating.

La Casita Del Arroyo Renovation Begins



A kickoff event this morning at 9 a.m. will officially commence the renovation of the historic La Casita del Arroyo. Join Vice-Mayor Jacque Robinson, Councilmember Steve Madison and La Casita Foundation representatives are expected to speak at the event.

La Casita del Arroyo will undergo an historic rehabilitation beginning this month. In 2012, the La Casita Foundation asked the City of Pasadena to participate in a public/private partnership to renovate this historic City-owned building at 177 South Arroyo Boulevard. Designed in 1932 by noted architect Myron Hunt, La Casita serves as a community meeting house for public and private functions.

The \$517,700 construction project will be managed by the Pasadena Department

of Public Works. The project includes upgrades to the restrooms, kitchen, great room and entry area; Americans with Disabilities Act (ADA) improvements; plumbing and electrical systems upgrades and restoration of the historic bicycle velodrome wood paneling. Exterior work includes parking lot improvements, roof replacement and new heating and air conditioning (HVAC) systems.

Funding comes from the La Casita Foundation, Pasadena Capital Improvement Project Fund and Residential Impact Fees. Project construction will be completed by B-One Construction Company, a local general contractor. Onyx Architects, a local Pasadena architectural firm designed the project, which maintains the building's historic integrity.

LEARNING TO DOWSE AT LA
COMMUNITY COLLEGE

theories were shared also.

“The light of dowsing shines brightest when helping humanity,” Legory would often tell us, meaning that we should not use this neutral skill to do any sort of harm.

One of the highlights of the class was when Ralph Harris showed up. Ralph Harris was maybe in his 60s, a Southerner with a red nose, and a very out-going and self-confident man. Harris didn’t lecture so much as he yelled at the class. He said that it was not good enough to be 60% right as a dowser, or 75% right, or 82% right. He said it was not good enough to be 95% right. Harris said that he was the son of a dowser, who was the son of a dowser, etc., and that it was a God-given art that still had to be practiced. Harris said you had to be 100% right to call yourself a dowser.

Harris explained to us one of his first public demonstrations at dowsing. Harris was a private in the Army under Patton in North Africa during WWII. They were stationed somewhere and needed water. According to Harris, Patton sent his 8 or so geologists into the desert to find water, and they reported that there was no water there. Harris then meekly went to Patton and explained that he knew how to dowsing, and that he believed he could find water if he had a little willow twig. Patton had an entire willow tree flown in the next day, and Harris cut a small Y shaped piece of the wood and walking into the desert. I no longer recall the exact figures that Harris told the class, but he located around a dozen sites where Harris believed water could be found by drilling. The first 4 or 5 spots drilled provided all the water that was needed by the troops.

Harris had all sorts of letters and documentations and maps and old newspaper articles as verification of everything he’d done, and everyone was amply impressed.

Harris said that when he practiced dowsing for people who wanted to dig a well on their properties, he’d never charge a penny unless water was found where he said, and at the depth he said. “Show me one geologist or well-digger who will do that!” bellowed Harris to the class.

Then, during one of the classes, Harris produced many maps of the Southern California area, and many letters which I never read. He told the class that he earned his money by dowsing for oil, and not only that, dowsing remotely! And he didn’t charge a fee, but he asked a percentage. No one asked what the percentage turned out to be, but

Harris implied that he earned a lot by those percentages.

I would have liked to get to know Harris better and to interview him, though he died within about 5 years after this.

It turned out that one could indeed dowsing with these many devices: forked stick, L-rods, pendulums. One Saturday, Ralph Harris showed us how to remote dowsing using a long spring with a magnet attached to the end. Most of the items he showed were purchased at hardware stores, and the long spring with the magnet was used by mechanics who accidentally drop a screw deep into some cavity of the car’s engine. Harris also had various home-made dowsing devices. One young man in the class picked up the long spring with the magnet and it went wild in his hand. I thought I was seeing things as the spring begun to spin around, yet the man’s hand was not moving, and he began to laugh at whatever was happening. Harris got red in the face and began to yell at the man: “You’re not focusing. You’re not controlling your thinking!” The man continued to laugh and was flabbergasted and Harris continued to yell at him. It was quite a show, and the long spring never did that in my hand.

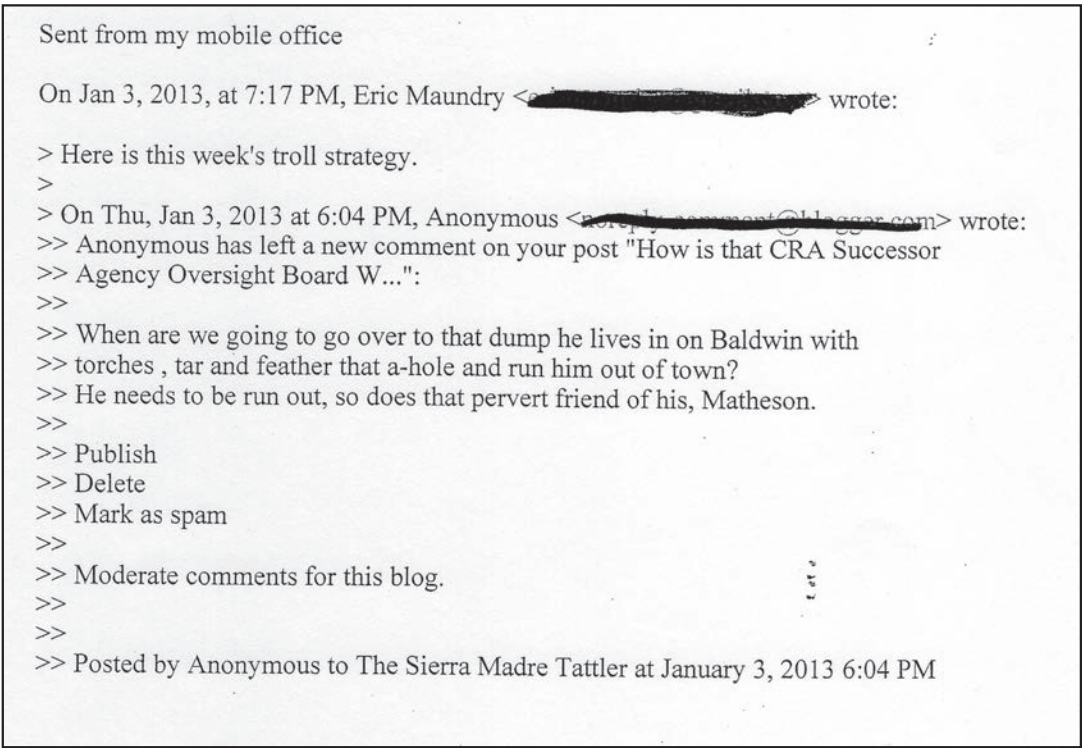
During the L.A. Community College class, we went across the street from the college to a vacant lot to practice dowsing. Our goal was to try and detect the metal pipes underground. The instructor knew where the pipes were, but the students didn’t. It gave us a chance to see what sort of dowsing abilities we had, and I did about average, but nothing exceptional. I always got the best results with copper L-rods.

In the years that followed, I would practice dowsing occasionally, trying to see if I could find things or even determine the answer to things by using a clockwise motion of the pendulum for “yes” and a counterclockwise motion for a “no” answer.

Unfortunately, many of my queries were of such a nature as to be unconfirmable without drilling or other extensive excavation. However, I did once dowse to find lost keys in a large field overgrown with tall grass, and I found them.

Dowsing seems to be one of those “lost arts” which skeptics love to debunk. I’m convinced that there’s more to it than meets the eye. It’s not so much about learning an external skill as it is about developing something within each of us that’s been dormant for a very long time.

mass media has used troll to describe “a person who defaces Internet tribute sites with the aim of causing grief to families.”

Over the years, there have been several residents that have suspected that Crawford engaged in the practice.

Enter the 2014 Campaign and dirty tactics:

Crawford’s use of the photos to pronounce Green unelectable is not the only effort the blog as made to apparently influence the outcome of the April 8th election.

Last year, a doctored photo of Former Mayor Josh Moran at a city event with Matheson appeared on Crawford’s blog along with a rant against Moran and suddenly, during the time that decisions were being made to run for council, that photo complete with vile remarks about Moran’s character surfaced anonymously in mailboxes around town. The original photo was taken prior to Moran or the public’s knowledge of the criminal activities of Matheson. Shortly after the mailings, Moran announced he would not seek re-election. Moran cited reasons other than the blog attacks and hate mail for choosing not to seek another term.

And on Thursday, the Mountain Views News and the author of this article were also under

attack for anticipated positions on the

User Utility Tax Measure. Both are frequently subject to misleading, out of context, and often downright inaccurate information in an effort to discredit the paper and the publisher. That just appears to be what Crawford’s blog is all about.

The kind of hatred and social media foul play that has been spread around Sierra Madre and beyond via the internet, has made several very qualified residents choose not to seek public office. They have expressed a willingness to serve, but no desire to become victim to the keyboard of The Tattler.

In a letter sent to all candidates by the Mountain Views News earlier this month, all were congratulated “for having the courage to step into the race for City Council.” That encouragement may not be enough for those who fall on the wrong side of issues with Crawford.

When discussing the issue of hostility in local politics these days with people around town, Sierra Madrean’s, regardless of their views on the issues or their choice of elected representation, do have one thing in common. They all want to preserve this Village town. The ways in which to do so are many and varied, but politics of the ‘trash and burn’ variety is not one of them.

MR. MANNERS

Must admit with all the past weeks Presidential food notes and trivial trivia, I almost missed National Margarita & Chili Days, and what type of foodie would I be, but fear not friends, I did partake in a Margarita and a hot bowl of beanless chili. I have to take my Andy Rooney Card out again and give you my fellow diners the rules of Etiquette 101. I love my daughter, and some of my friends kids. But here goes.

I am asked frequently asked about etiquette and table manners, so I compiled this simple list based on the most common questions.

Your napkin goes in your lap, folded in half, as soon as you sit down. Many people wait until the food arrives, but the proper form is to be prepared.

If you leave the table, place the napkin to the left of your plate, loosely draped. A napkin is never for blowing your nose or wiping your mouth. Use it to dab at the corners of your mouth or your fingertips. If you need to cleanse further, leave the table and use the appropriate products in the restroom.

In formal dining, a charger will be under the place setting. It remains there during the starter course and is removed at the main course.

Your eating utensils go in the order of use, starting from the outside (furthest from the plate) and working their way in. Forks go on the left; knives and spoons on the right, as you face the plate. Dessert utensils are placed at the top of the plate, sideways.

The bread and butter plate goes to the left, above the forks.

The water glass goes above the knives (behind the wine goblet, if there is one).

Food should be passed counter-clockwise.

It is considered impolite to start eating before everyone is seated and served, including your host.

Only the meal settings and food belong on the table. Do not place your elbows, eyeglasses, notebook, pen or other objects on the table.

Cut no more than two bites of any item at a time. When it comes to bread, tear off one bite at a time and butter it, rather than buttering a whole roll.

Do not season your food until you have tasted it.

It is permissible to use a piece of bread to wipe up excess gravy, as long as you use your fork and not your fingers.

If you need to leave the table, place your utensils on the edge of your plate so that the tips point to the plate's center, in a V-shape. To signal when you are finished, lay your utensils side by side diagonally on the plate.

THE PLIGHT OF PROHIBITIVE PET CARE COSTS

During a recent conversation with a close friend, our casual dialogue eventually found it's way to a discussion about our beloved pets, as it typically does. My friend and his wife have two darling dogs whom they love very much and treat like family members. They spend loads of time with their dogs, and enjoy their company more than most pet owners do.

During the course of our conversation, my friend mentioned that he had taken one of their dogs, the older of the two, to the veterinarian a week before, and even with the senior citizen discount his vet applies, he still ended up paying just short of an arm and a leg for a few lab tests and a quick exam. He was quite surprised at how pet care costs have sky-rocketed these days and when he told me how much the bill was, it took me very much by surprise as well. Listening to his story, I thought of how many pet-owning senior citizens probably find themselves in a similar situation, met with the difficulty of covering the costs associated with caring for their pets.

Most seniors are retired with a very limited income, and if that is not challenging enough, our present-day economy is making it even more difficult for them to make ends meet. Nowadays many of the seniors who were fortunate enough to have put money away for later years while working, have had to use their nest-egg savings just to keep their homes and pay off their own medical bills.

Retirement is when most people finally have time to spend with a pet, and perhaps when they need that kind of companionship more than ever before, so it seems ironic and quite a shame to think that the cost of a vet bill could prohibit them from caring for their pet properly, or heaven forbid in the saddest case scenario, force them to euthanize to avoid the high cost of keeping their pet alive.

Later that day, I was still thinking about the subject we had discussed and I could not seem to get that conversation out of my mind. Being a dog walker and pet sitter, I guess it struck a tender spot in my heart. I decided to look into what, if any kind of assistance might be available for senior citizens who cannot afford the high costs associated with caring for their animal companion. What I found was that there are several programs in place that offer pet vet bill and/or pet care assistance to senior citizens who qualify. Here are a few of the programs and services I found:

Actors and Others for Animals is a California non-profit corporation dedicated to the humane treatment of animals. Their main mission is to curb the pet overpopulation problem by subsidizing spay

& neuter surgeries along with other vital services to help pet guardians, living on a low and/or fixed income, care for their beloved companions. One of their programs is SpayCalifornia, a state-wide referral network/database to connect people throughout the State of California with participating programs and veterinarians offering low cost spay/neuter services. PAWS/LA was founded in 1989 in response to the companion animal-related crises faced by residents of Los Angeles County who were financially and physically debilitated by HIV/AIDS. Since that time, the agency has expanded its scope to assist low-income seniors and any low-income individual living with a chronic or life-threatening illness. Their PACE Program (Preserving Animal Companionship for the Elderly) assists seniors by providing assistance with pet care. It has been documented through numerous scientific studies that the positive correlation between seniors and animals improves emotional outlook and health stability and PAWS/LA wants to help. The Pet Fund is a non-profit association that offers financial assistance to owners of domestic animals who need veterinary care. Their purpose is to work towards a future where decisions about companion animal medical care, need not be made on the basis of cost. Perhaps most importantly, they provide information about preventative care, pet insurance programs and financial services to help the pet owner develop resources on their own and avoid future emergencies through proper care and planning. Such information is often hard to find and The Pet Fund provides a user-friendly, easily accessible starting place for this purpose. It pleases me to know that there are so many people who care enough about domestic pets and their owners, to invest their time, money and energy in developing programs that can help maintain a healthy relationship between the two. It serves as a reminder to look for the proverbial "rainbow after the storm". Let's face it, if this article had ended where the conversation between me and my friend ended, it would have been quite bleak. Fortunately, however this tale has a happy ending. It serves as a reminder that where you find a friend in need, you will most likely find a friend in "deed"!

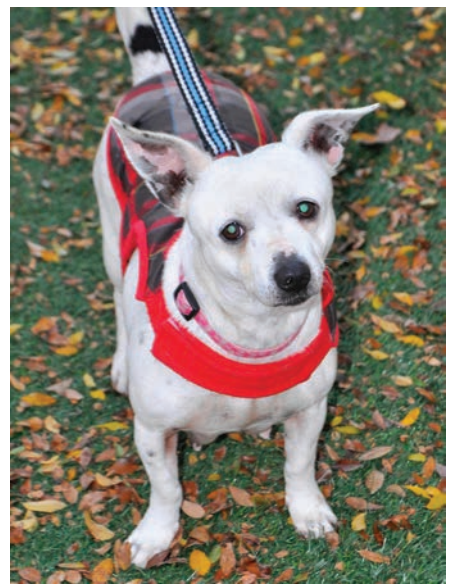

SEAN'S SHAMELESS REVIEWS:

SNOWMINE

Taking the alternative route of self-releasing their sophomore album, "Dialects," Snowmine's follow-up to their underrated debut record "Laminate Pet Animal" is a different kind of an animal entirely. This new perspective

has the band entering into a brooding territory. In fact, with these eleven brand new tracks, the band feels more comfortable and determined than ever before. While the first album was completely unique in its own right, it was a bit all over the place. It was really good, but felt very much like a debut record. A little bit misguided. "Dialects" displays Snowmine in a different light. The many talents of the band are put forth on this record. There is sort of an experimental element to the album, which was recorded in a church. A lot of ambience is presented and weird quirks/sounds to give it a unique experience unlike other indie acts in the same arena. While "Dialects" is far from the perfect indie rock album, it's still a solid, if a bit uneven entry that shouldn't be ignored or missed.

One of the best tracks of the year is to be found here. "Plans" is an absolute delight. It has such a distinctive sound that makes it totally original from the band. When it breaks into the chorus, it just explodes into sheer beauty. For the most part, this is a slow tempo album. It combines interesting sounds along with Grayson Sanders' sometimes crooning vocals. While the record doesn't quite have that alluring element of being listened to over and over again, it's the kind of record you come back to after a period of time away from it. Not every track is golden and some songs can be simply passed on. However, the tracks that do work, "Plans," "Columbus," "You Want Everything," "Courts," and "Dollar Divided" make the experience a memorable one for at least the time those tracks are playing. The other half the album is acceptable, but they take some chances that don't always pay off accordingly. "Safety in an Open Mind" is purely instrumental. It can be considered an intermission track as we approach the second half of the album. It has these washed out effects. It's a peaceful tune, but doesn't push the album any forward.

"Dialects," for the most part, has a laid-back sound. The instruments are eclectic and despite some less than stellar tunes, Snowmine aren't trying to mimic anyone. They're completely original. Perhaps, the tunes that don't resonate first or second time need some more listens before you can actually appreciate them. The problem with music today is how one might not want to give songs a chance when there's just too much music to hold onto from the moment you hear it. At any rate, Snowmine is an underrated band that is trying to press forward and make a name for themselves. While the path they may be on seems a bit crowded, they definitely have the aptitude to find a way around in order to finally find that open road. Once there, there's no telling what Snowmine can do, but I know I'll be carefully watching to see where it ultimately leads them.

ONE SUMMER: AMERICA, 1927 by Bill Bryson

The title of the book sums up his task: to document the "most extraordinary summer" of 1927, beginning with Charles Lindbergh's fantastic flight across the Atlantic. Even though we know many of these stories; Lindbergh's flight, the Mississippi River flood, Babe Ruth's 60-homerun season, Al Capone's bullet-ridden reign over Chicago, in Bryson's hands, they feel fresh, and just plain fun. The book is jammed with nuggets and fascinating origin stories (the opening of the Holland Tunnel, the first Mickey Mouse prototype, the source of the term "hot dog"), the effect is like sitting beside a brilliant story teller, who knows a little bit about everything. From a tabloid murder trial to a flagpole sitting record to the secret origins of the Great Depression, One Summer offers a wonderful look at a transitional period in history, re-introducing us to such characters as Capone, Al Jolson, Jack Dempsey, Charles Ponzi, and Herbert Hoover. Ultimately, this is a book about the moment when important things, for good or bad, began happening in the US. With an easy to read narrative and keen eye for unusual details, best selling author Bryson has written a clever historical tale of America's coming of age.

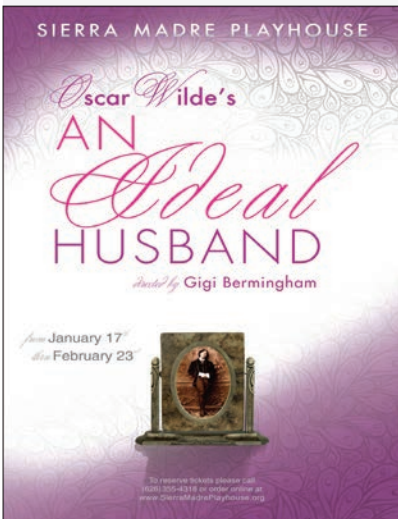

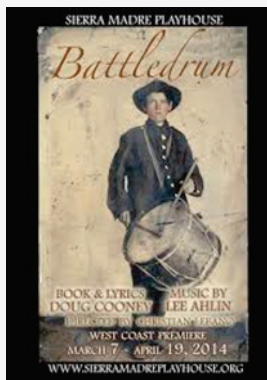
NEWS FROM THE SIERRA MADRE PLAYHOUSE

There is no question that there is enough evidence out there that shows that our family passes on DNA (information in our genes) that predisposes us to being more susceptible to diseases than maybe our neighbor. More important though than DNA is lifestyle. In particular your lifestyle and what you eat. I tell all of my clients that "your DNA loads the gun but your lifestyle pulls the trigger". To date, heart disease remains the leading cause of death in the United States for both men and women. If you could simply change the way you eat and either prevent getting heart disease or reverse the heart disease you already have would you do so?

The evidence is pretty compelling, a plant based diet lowers your risk of ever developing heart disease and may reverse or certainly lessen the severity of existing heart disease. Even former president Bill Clinton who was notoriously known for having a less than healthy diet has seen the light. During his time in the White House he was known to try and jog off his fast food binges. It worked and he was able to pass all of his health checks while he was president. During that time his heart disease was progressing. In 2004 Clinton underwent bypass surgery and in 2010 that surgery failed. Later that year, Clinton began a plant-based diet. The result, he began to feel great, he lost weight and his heart disease began to reverse itself.

In an analysis published in 2009 in the American Journal of Cardiology, a plant based diet has been shown to: Lower levels of triglycerides, lower blood pressure, decrease body weight, decrease risk of death from any cause including heart disease, improves insulin sensitivity and more. So, if you have high cholesterol, or you know someone who does, checking out a plant based diet may be well worth your time. Adjusting your diet may be one way to lower your cholesterol and prevent heart disease.

TIPS AND SUPPORT SERVICES FOR FAMILY CAREGIVERS

Dear Savvy Senior:
What resources do you recommend that offer help to caregivers? I've been taking care of my 82-year-old mother, and it's wearing me to a frazzle.
Exhausted Daughter



Dear Exhausted:
Taking care of an elder loved one over a period of time can be incredibly taxing, both physically and mentally. Fortunately, there are a number of tips and services you can turn to that can help lighten the load. Here are several to consider.

Assemble a care team: A good first step is to put together a network of people (family, friends and even neighbors) that you can call on to help out when you can't be there or need a break.

Tap local services: Most communities offer a range of free or subsidized services that help seniors and caregivers by providing things like home delivered meals, transportation, senior companion services and more. Also, look into respite services (see respitelocator.org) that can provide short-term care to your mom so you can take some time off. Your Area Agency on Aging (call 800-677-1116 for contact information) can refer you to services available in your community.

Use financial aids: If you're handling your mom's financial chores, make things easier by arranging direct deposit for her income sources, and set up automatic payments for her utilities and other routine bills.

If you need help, hire a professional daily money manager (aadmm.com, 877-326-5991) who can come in once or twice a month to pay bills, make deposits, decipher health insurance statements and balance her checkbook. They charge \$25 to \$100 per hour. Or, if your mom is low-income, a similar service is offered by AARP (aarpmpmp.org) in select communities for free.

Benefitscheckup.org is another excellent resource you should use to look for financial assistance programs for lower-income seniors.

Get insurance help: If you have questions about Medicare, Medicaid or long-term care, your State Health Insurance Assistance Program (SHIP) is a great resource that provides free counseling on all these issues. Call 800-633-4227 or visit shiptalk.org to locate a nearby counselor.

You can also get help online at medicare.gov/campaigns/caregiver/caregiver.html, and through the Medicare Rights Center, which staffs a hotline at 800-333-4114 to help answer questions.

Use technology: If your mom lives alone, consider renting her a medical alert device, which is a small pendant-style "SOS" button that she wears, that would allow her to call for help if she falls. These are available through companies like lifelinesys.com and lifecycle.com for about \$1 per day. Or, check out home monitoring systems at mylively.com, beclose.com or grandcare.com.

There are also a number of great websites you can draw on for caregiving information and support like aarp.org/caregiving, caregiver.org and caring.com, along with alz.org/care, alzheimers.gov and thiscaringhome.org for caregivers of dementia patients. And, if you're sharing care responsibilities with others, sites like lotsahelpinghands.com, caresolver.com and caringbridge.org can help you coordinate together.

Hire help: Depending on your mom's needs and budget, you may want to hire a part-time "home-care aide" that can help with things like preparing meals, doing laundry, bathing or dressing, or if she needs health care services, a "home health aid." Costs can run anywhere from \$12 up to \$40 per hour depending on where you live and the qualification of the aide. To find someone, ask for referrals through friends, doctor's offices or hospital discharge planners, or visit medicare.gov/homehealthcompare.

If you need additional guidance, consider hiring a geriatric care manager (caremanager.org) who can help you manage and facilitate your mom's care. Care managers generally charge between \$100 and \$200 per hour.

Take care of yourself: Make your own health a priority. Being a caregiver is a big job that can cause emotional and physical stress and lead to illness and depression. The only way you can provide the care your mother needs is to make sure you stay healthy.

KATIE Tse.....This and That FIBER NUTS - 2014!

What's more fun than three days of fiber-filled creativity and excitement in the San Bernardino Natural Forest? Why, three days of fiber-filled fun in Rancho Cucamonga, of course! (This is fiber, as in yarn and thread, not the kind you eat.)

You may recall an article I wrote around Mother's Day last year about my mom's excursion to "Studio 66," a three-day workshop hosted by her weaving group. If you do remember this, you're probably one of my mom's friends with whom she's shared this story. For all other readers, I'll refresh your memory.

Last year I was lucky enough to accompany my mom as she and her friends spun, dyed, wove, knit, and crocheted all imaginable fibers at the picturesque Forest Home retreat center. Being unskilled in everything but the most basic dyeing (submerging fabric in colored liquid) I got a lot of use out of my kindle!

I would've loved to go with her up there again this year, but since that retreat is somewhat costly and requires months of planning, it's only offered biannually. On the off-years, "Studio 66" is more locally based, with attendees making the daily commute from their home. There's no cabin in the forest or meals crafted by aspiring culinary students. Since there isn't the same wide variety of workshops available, the event usually revolves around a specific theme. This year the focus was spinning. (And no, this doesn't refer to a bunch of ladies pedaling stationary bikes.)

For three days my mom and her classmates worked with cotton (white, brown, and green), linen, hemp (to spin, not to smoke), and ramie. I knew the first two were used in clothing, and the third in industrial-strength items, like sacks, ropes, wallets, and shoes. Ramie, however, was new to me. (Not that it takes much for something to be "new to me!")

The first day went fine for my mom, but the second was a serious study of cotton's transformation from boll to thread. Now, cotton is very different from wool, my mom's spinning material of choice. Wool (from sheep, that I do know!) is composed of long fibers that easily wrap around each other to form a nice, long strand of uniform thickness.

Cotton (regardless of its color) is made up of short fibers that tend to break apart or clump together. At least that's what my mom's experience was with them. So, my poor mom spent much of the second day feeding a hank of cotton onto her spinning wheel, only to have it snap in two or bunch up. She came home with a few bobbins of cotton thread resembling diseased intestines, with some sections pinched off and others bulging.

She spent the whole day attempting the same action over and over, knowing that it wasn't working, but unable to do anything to improve her results. The instructor came by from time to time, smiled sympathetically, and encouraged my mom to keep on trying. It was frustrating, to say the least. As a retired third-grade public school teacher, my mom discovered a new understanding of the kids who struggled with learning disabilities. If being the only one who couldn't master a seemingly simple technique was discouraging enough for one day, spending an entire elementary experience like that must be torture. Coming home, she suggested that every educator spend at least one day being the only one who doesn't "get it" in order to appreciate what these kids feel on a daily basis.

Happily, the workshop didn't end on a sour note. On the third day, the instructor showed my mom how to wrap the hank of hemp around her finger to "spin off the fold." This method was much easier for my mom, and she also realized that the rest of her classmates were seasoned cotton-spinners, not a novice like her.

So, my mom enjoyed another "Studio 66" retreat. Granted, the strip malls of Rancho Cucamonga pale in comparison to the pines and lakes of the San Bernardino Forest, but it's all fiber, so it's all good!



SENIOR HAPPENINGS

FYI: Tips for Talking with Your Pharmacist

Your pharmacist can help you learn how to use your prescription and nonprescription (over-the-counter) medicines safely and to increase the benefits and decrease the risks. You can also use these tips when talking with your other healthcare professionals.

Tell your pharmacist...

Everything you use. Keep a record and give it to your pharmacist. Make sure you put all the prescription and nonprescription medicines, vitamins, herbals, and other supplements you use. Your pharmacist will use this to keep his/her records up-to-date and help you use medicine safely.

If you've had any allergic reactions or problems with medicines, medicines with dietary supplements, medicines with food, or medicines with other treatments.

Anything that could affect your use of medicine, such as, if you have trouble swallowing, reading labels, remembering to use medicine, or paying for medicine.

Ask your pharmacist...

What are the brand and generic (non-brand) names? What is the active ingredient? Can I use a generic? What is this for, and how is it going to help me? How and when should I use it? How much do I use? How long should I use it? Can I stop using the medicine or use less if I feel better? What should I do if I ...miss a dose? ...use too much? Will this take the place of anything else I am using? When will the medicine start working? How should I expect to feel? Are there any special directions for using this? Should I avoid any other medicines, dietary supplements, drinks, foods, activities, or other things? Is there anything I should watch for, like allergic reactions or side effects? What do I do if I get any? Will I need any tests to check the medicine's effects (blood tests, x-rays, other)? When will I need those? How and where should I keep this medicine? Is there a medication guide or other patient information for this medicine? Where and how can I get more written information?

After you have the medicine, and before you leave the pharmacy

Look to be sure you have the right medicine. If you've bought the medicine before, make sure this medicine has the same shape, color, size, markings, and packaging. Anything different? Ask your pharmacist. If it seems different when you use it, tell your pharmacist, doctor, or other healthcare professional. Be sure you know the right dose for the medicine and you know how to use it. Any questions? Ask your pharmacist.

5 FAST & FURIOUS ESTATE PLANNING LESSONS FROM PAUL WALKER’S ESTATE

Paul Walker, who starred in the Fast & Furious movie franchise, died tragically at the age of 40 in a high speed car accident in Los Angeles last November. His estate was opened at the end of January in the Superior Court of California, County of Santa Barbara probate court, revealing that he left assets of approximately \$25 million. He is survived by his 15-year-old daughter, Meadow.

So what can we learn by looking at the probate of Paul Walker’s Estate?

Put assets in a trust. Paul Walker intended to avoid the Court process called probate by creating a revocable living trust. A trust makes everything totally private and keeps it all out of Court. Unfortunately, while Paul Walker had a Trust, it wasn’t properly funded – in other words, his assets were never transferred into the trust ... and this is an all too common estate planning failure, even when working with a lawyer because most lawyers simply do not handle trust funding, the single most important part of estate planning.

Properly fund your trust. The contents of Walker’s estate, who will inherit it and when, are now public knowledge because Walker’s lawyer didn’t take the necessary steps to make sure his Trust was properly funded. Sadly, this isn’t even a case of malpractice (though it should be) because it’s common practice in the world of estate planning lawyers. When you plan your estate, the most important thing you can do is ensure your assets are transferred properly.

Name guardians for minor children. Walker’s daughter, Meadow, is still a minor and he did name his own mother as guardian. But if he had not, there could have been a family fight, and a judge would have stepped in to make the final decision about who would raise Meadow. By nominating guardians you can avoid family fights over your children (and the assets that follow them) or ever having a judge – a total stranger – decide who will raise your children.

Don’t wait to do estate planning. Walker was 28 when he created his will in 2001. While we don’t know what prompted him to create an estate plan so early – perhaps it was the birth of his daughter– he did the right thing in planning early. Everyone over the age of eighteen should have a will, and if you have children you’ll want a more comprehensive estate plan so they are always protected and provided for, no matter what.

Keep estate plans updated. Not only did Walker’s attorney not ensure his assets were titled properly, but he never updated Walker’s plan from the original version created 12 years before he died. Walker’s net worth changed significantly during that time. If his estate is \$25,000,000, as we’ve read, his family must pay over \$5,000,000 in estate taxes. I think that’s unconscionable because with proper planning that could have all been structured to pass on to his family instead of the Government. To make sure all of your assets go to your family, you should update your estate plan at least every three years.

WHEN DO YOU WANT TO RETIRE?

It’s not a trick question, but the difference between answering “when I want to” vs “when I can afford to” is dependent on understanding what retirement will look like and what assets you’ll need to achieve that goal.

Historically, a combination of social security and some other source of fixed income (the traditional pension or annuities) would be sufficient. Sadly, social security is almost bankrupt, and inflation has reduced the guarantee that was the pension or annuity. The old rules and guidelines just don’t apply, but too many Americans act as if they still are valid.

According to one study, less than 35%of middle class Americans have a written retirement plan - even on the back of a napkin. They just don’t know what it’s going to take to retire at any age. People are saving blindly without a sense of how they’re doing or really where their path will lead. In another study, almost one third of people eligible to retire at the “normal” age of 65 indicated they would continue to work until age 80 because they felt they lacked the means to retire earlier.

When it comes to retirement, putting your head in the sand is not an effective strategy. Here, then, are some simply steps to take.

Write Out A Plan: It really could be on the back of a napkin; there is no magic to how many pages you need. Putting down on paper where you are now, where you want to go and what you think will get you there are the most important components.

Don’t Forget Taxes: The logical place to start is to consider what you’re spending now to live the life you want. You have to remember that in retirement, taxes will be part of these expenses. During your working years, taxes are taken out of the paycheck before you get it. Too many people forget that. What you’ll need in retirement is your living expenses plus taxes.

Maintain A Balanced Portfolio: Social security,



pensions and annuities are all fine tools to use, but they can’t be the exclusive strategy. Nor is having an investment portfolio that is too heavily skewed toward bonds or stocks. You need to balance the tools you use and balance your portfolio, whether that portfolio is in a 401K, an IRA, a Roth, or a regular taxable account. Diversification works.

Ask For Help But Get What You Pay For: It really is OK to ask for help. None of us should attach ego or pride to those areas where we’re not proficient. I’m not good at plumbing or car repairs. I’ve learned to reach out, but I’m mindful of what I’m buying. If you need financial advice, make sure it’s objective, ask for references, and ask for a full disclosure of ALL fees that would be charged.

These are just a few simple concepts, but they really can help. The earlier you start, the more successful you’ll be, but I’ve never run into someone who can’t retire at some point. You’ll get there, you just need to know the way.

DON'T RISK IT

When listing your home, you may need to move before a sale takes place. If you vacate the home, it's very important that you notify your insurance company, because many homeowner policies have a "vacancy clause" that goes into effect once the home is unoccupied, usually for more than 30 to 60 days.

Insurers see different risks in vacant homes, like vandalism, systems failures, or other liabilities. In most cases, you'll simply purchase an endorsement to your existing policy, but different insurers have different options, and if an endorsement is not available, you can get a separate "vacant-home" policy. It may be an additional cost, but it's called "insurance" for a reason, and could save you a lot of money down the road. If you don't notify your insurance agent about vacating your home, they could reject any claims you file for property damage or liability, or accuse you of insurance fraud.

It may be tempting to just hope that your home will sell within 30 to 60 days after you have to move out, but it's critical to speak with your insurance agent before you move to discuss your options. They may even pro-rate and refund part of your premium if you sell before the end of the policy's term. It's a small price to pay to protect your home and your peace of mind.

MARS ROVER HEADS UPHILL AFTER SOLVING 'DOUGHNUT RIDDLE'

Researchers have determined the now-infamous Martian rock resembling a jelly doughnut, dubbed Pinnacle Island, is a piece of a larger rock broken and moved by the wheel of NASA's Mars Exploration Rover Opportunity in early January.

Only about 1.5 inches wide, the white-rimmed, red-centered rock caused a stir last month when it appeared in an image the rover took Jan. 8 at a location where it was not present four days earlier.

More recent images show the original piece of rock struck by the rover's wheel, slightly uphill from where Pinnacle Island came to rest.

"Once we moved Opportunity a short distance, after inspecting Pinnacle Island, we could see directly uphill an overturned rock that has the same unusual appearance," said Opportunity Deputy Principal Investigator Ray Arvidson of Washington University in St. Louis. "We drove over it. We can see the track. That's where Pinnacle Island came from."

Examination of Pinnacle Island revealed high levels of elements such as manganese and sulfur, suggesting these water-soluble ingredients were concentrated in the rock by the action of water. "This may have happened just beneath the surface relatively recently," Arvidson said, "or it may have happened deeper below ground longer ago and then, by serendipity, erosion stripped away material above it and made it accessible to our wheels."

Now that the rover is finished inspecting this rock, the team plans to drive Opportunity south and uphill to investigate exposed rock layers on the slope.

Opportunity is approaching a boulder-studded ridge informally named the McClure-Beverlin Escarpment, in honor of engineers Jack Beverlin and Bill McClure. Beverlin and McClure were the first recipients of the NASA Medal of Exceptional Bravery for their actions on Feb. 14, 1969, to save NASA's second successful Mars mission, Mariner 6, when the launch vehicle began to crumple on the launch pad from loss of pressure.

"Our team working on Opportunity's continuing mission of exploration and discovery realizes how indebted we are to the work of people who made the early missions to Mars possible, and in particular to the heroics of Bill McClure and Jack Beverlin," said rover team member James Rice of the Planetary Science Institute, Tucson, Ariz. "We felt this was really a fitting tribute to these brave men, especially with the 45th anniversary of their actions coming today."

Opportunity's work on the north-facing slope below the escarpment will give the vehicle an energy advantage by tilting its solar panels toward the winter sun. Feb. 14 is the winter solstice in Mars' southern hemisphere, which includes the region where Opportunity has been working since it landed in January 2004.

"We are now past the minimum solar-energy point of this Martian winter," said Opportunity Project Manager John Callas of NASA's Jet Propulsion Laboratory in Pasadena, Calif. "We now can expect to have more energy available each week. What's more, recent winds removed some dust from the rover's solar array. So we have higher performance from the array than the previous two winters."

During Opportunity's decade on Mars, and the 2004-2010 career of its twin, Spirit, NASA's Mars Exploration Rover Project has yielded a range of findings proving wet environmental conditions on ancient Mars—some very acidic, others milder and more conducive to supporting life.

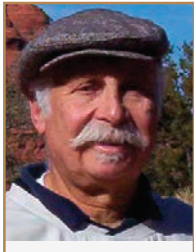

Seventy-six years later, certain members of the most powerful class refuse to accept this information and utilize their influence and their money to continue to delude the public. If the world has come to accept racial equality and sexual practice variation it can be hoped there will be a global recognition of the need to alter the destructive practices that are destroying the habitability of this planet. It's been in the news a while, but when I saw Greg Welborn using it as the basis for warning that "America is disappearing", I thought I'd look into the Congressional Budget Office's "Budget and Economic Outlook: 2014 to 2024" for myself.

The report forecasts the budget deficit for FY 2014 coming in at \$514 billion – down from the \$1.4 trillion 2009 deficit President Obama inherited from George W. Bush. That's 3% of GDP – about average for the past forty years.

Deficits are projected to get smaller over the next couple years, but then to start rising – fueled by an aging population, increased healthcare costs, and growing interest on the national debt. Leaving aside Social Security, health programs and interest on the debt, remaining federal spending would be a smaller percentage of GDP than at any time since they started keeping track of these numbers back in 1940.

The report projects 3% growth in GDP from fourth-quarter 2013 to fourth-quarter 2014, the highest rate in a decade. Growth will continue through 2017 with low inflation, but, with a strengthening economy, interest rates will rise and unemployment will continue hovering above 6%.

Those are the basics. What made news, though, is found back on page 117, Appendix C – "Labor Effects of the Affordable Care Act: Updated Estimates". The report concludes that low-income subsidies available through the exchanges and expansion of Medicaid will have an effect on those who'd been working simply to maintain health coverage. In the period 2017 through 2024, the CBO figures there will be 1.5 to 2% fewer work hours put in as a result – all told the equivalent of 2-to-2.5 million full-time jobs. Mainly involving low-wage workers, the effect is a 1% drop in "aggregate labor compensation over the 2017-2024 period".

(Employment will continue to increase; reductions are not to the numbers as they are now, but to what the increase over the next ten years otherwise would have been.)

This is where the right-wing media thought they had a real "Aha!" moment. Over on Fox News, there was breathless reporting on the "bombshell" from the CBO revealing the "killing" of 2 million jobs under "Obamacare".

Rep. Eric Cantor (R- VA) tweeted, "Under Obamacare, millions of hardworking Americans will lose their jobs and those who keep them will see their hours and wages reduced."

This brought Paul Krugman's response as quoted above, which began, "... was Mr. Cantor being dishonest? Or was he just ignorant of the policy basics and unwilling

to actually read the report before trumpeting his misrepresentation of what it said?"

CBO Director Doug Elmendorf, in fact, was called before the House Budget Committee to explain the difference between labor supply and labor demand; the difference between not being able to find work and choosing not to – with the prospect of losing health coverage no longer hanging over your head. Elmendorf added that the poorest Americans would now have money freed up to spend in other areas of the economy, and that "on balance, CBO estimates that the ACA will boost overall demand for goods and services over the next few years."

Immediately following the report's release, the political press didn't bother with what it said (6 million enrolled through the exchanges, 25 million Americans with health insurance because of the ACA), but of the "devastating" impact on Democrats in the upcoming mid-terms, as Republicans campaign on "2 million jobs killed by Obamacare".

The public, however, was ahead of the press on this one. For those who thought about it, it wasn't "2 million jobs killed"; but acknowledgment by the CBO that 2 million Americans have been locked into dead-end jobs solely to preserve health coverage – a situation incomprehensible in any other advanced economy in the world.

Okay, maybe folks weren't buying the "jobs killed" line anymore – so the talking points shifted into resentment towards subsidizing, as Greg put it, those "freeloaders who want to photograph butterflies mating and float crucifixes in ..." (you know the rest). Few, if anybody, are buying this line, either.

In reality, benefits provided through the ACA's subsidies and Medicaid expansion promote values long-espoused by conservatives, as well the rest of us. A young mother is freed to spend more time at home with her children rather than at a job solely to protect health benefits; seniors, after a life of hard work, spend time with grandkids instead of at a bottom-rung job waiting for Medicare eligibility; those with dreams of becoming the next Ford, Edison or Steve Jobs can take what they've borrowed from family and the SBA and actually pursue, in Greg's words, "the America of opportunity, upward mobility and freedom". Americans don't need lectures from Sen. Paul Ryan (R-WI) on how this freedom deprives them of the "dignity of work", or, according to Greg, their "purpose and self-esteem".

Ironically, according to the CBO report, work is most discouraged in those red states which turned down the ACA's expansion of Medicaid benefits. Elsewhere, you can go out and get part-time, low-wage (up to 138% of poverty level) work and keep your benefits. In Republican-led states rejecting the ACA, however, the choice is to either stay unemployed and in poverty, or lose health coverage for yourself and your family.

Greg warns that "This will become the America where wealth is given to those who best learn to game the system and/or who are politically connected." For many Americans, it already is. Accordingly, there won't be such "willful ignorance" as they go to the polls this November.

LIBERALISM'S DEATH GREG Welborn

I came of age politically admiring the liberalism of John Kennedy. Perhaps I was naïve, but it seemed to embody the best of American values. Liberalism today is nothing like that. There have been plenty of warning signs, but this administration seems to have a knack for redefining downward what it means to be "liberal". The most recent example is the FCC's desire to send "researchers" into newsrooms across America to grill editors about the decisions they make on which stories to highlight and pursue. If that doesn't seem like a violation of traditional liberal philosophy, I'm not sure what would. That got me to thinking, so I'm proposing a test for all who consider themselves "liberal". Consider the following carefully. Where do you stand on each issue?

1. The Federal Communication Commission (FCC) will, according to one of its own commissioners, "grill reporters, editors and station owners about how they decide which stories to run."

2. The President of the United States announces he will bypass Congress by simply using his "pen" to sign whatever executive order is necessary to accomplish his purposes. Gone is any attempt to negotiate, cajole, or horse trade. Gone is the pretense of democratic governance.

3. The IRS is allowed (those more cynical might say directed) to target conservative groups seeking non-profit status.

4. The Justice Department spied on reporters by eavesdropping on phone conversations and pulling emails of reporters without the benefit of a search warrant.

5. Poor parents should not be allowed access to private or parochial schools that wealthy liberal politicians themselves use for their kids.

6. The minimum wage should be raised because it will benefit those who keep their jobs, even as it causes the unemployment of 500,000 of those on the lowest end of the wage scale.

7. Speech should be regulated on college campuses so that it doesn't offend certain favored groups.

8. High schools should hand out condoms to students because they'll "do it anyway", but restrict cigarettes

because "they'll listen to us if we teach them".

9. No matter the stage of pregnancy, every woman should have the right to choose, but no fetus should have the right to life, liberty and the pursuit of happiness.

10. But, it is immoral to terminate the life of any murderer no matter how heinous the murder.

11. It is wrong for students to hear "God bless you" at their graduations.

12. The United States and Russia are morally equivalent, thus Russia should be our equal partner in handling issues in the Ukraine, Syria and Iran.

I may be accused of prejudice or cherry picking in compiling the above list, but I would ask those who hurl such accusations to point to specific, concrete evidence of where I have misrepresented the mainstream Liberal position of 2014.

No political party is immune from corruption of its ideals. The key is whether the substantial number of Americans who would self-identify as liberal would object to what's being articulated as "liberal" orthodoxy today.

I wrote this article with the knowledge that I have always been a liberal as that term was normally defined. I would have been a liberal in 1776, during the Civil War, and with the civil rights workers in the South. But I can't identify with what passes for liberalism today. 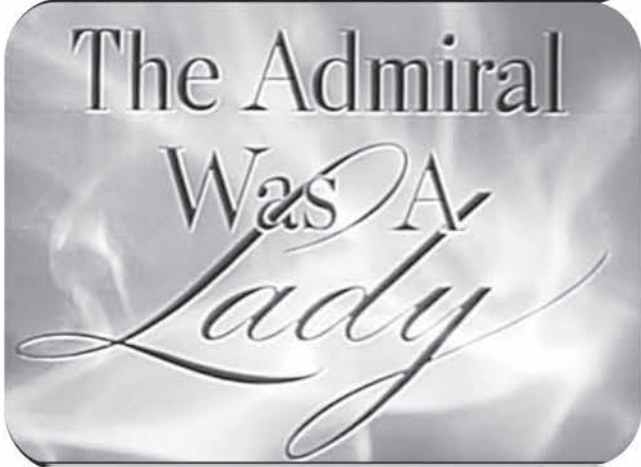
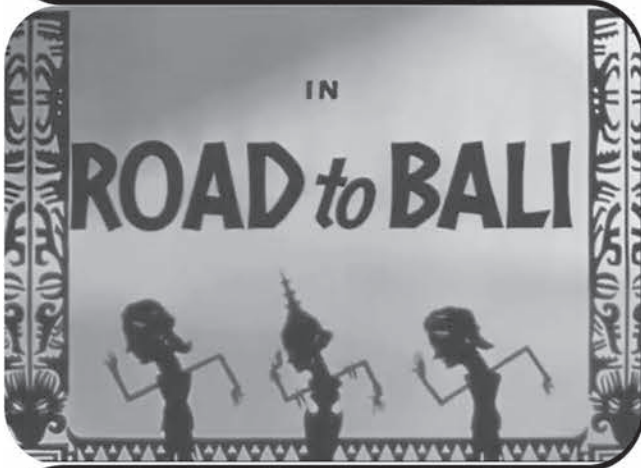

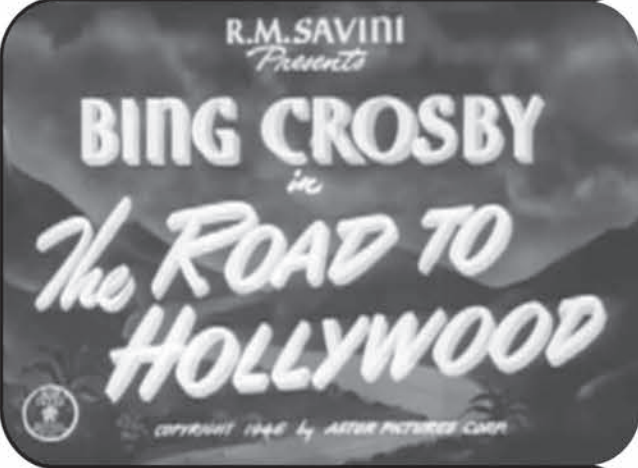

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Sierra Madre as follows:

SECTION 1. Code Amendment. The definition of “transitional housing” in Section 17.08.020 of the Municipal Code entitled “Words, terms, phrases defined” is hereby amended to read: “Transitional housing” means rental housing provided to facilitate the movement of homeless individuals or families to conventional housing. Transitional housing may take the form of single-family or multi-family units, and may include supportive services operated under program requirements to allow individuals or families to gain necessary life skills in support of independent living. This type of housing may be occupied by a program recipient for a minimum of 6(six) months up to a maximum of 2(two) years, at which time it may be recirculated to another eligible program recipient.

SECTION 2. Code Amendment. Section 17.08.020 of the Municipal Code entitled “Words, terms, phrases defined” is hereby revised to include: “Supportive housing” means housing with no limit on length of stay that is occupied by the target population as defined in the Health & Safety Code Section 53260(d), and that is linked to onsite or offsite services that assist the supportive housing resident in retaining the housing, improving his or her health status, and maximizing his or her ability to live and, when possible, work in the community.

SECTION 3. Code Amendment. Section 17.08.020 of the Municipal Code entitled “Words, terms, phrases defined” is hereby revised to include: “Emergency shelter” means housing with minimal supportive services for homeless persons that is limited that is limited to occupancy of six months or less by a homeless person. No individual or household may be denied shelter because of an inability to pay.

SECTION 4. Code Amendment. Section 17.02.020 of the Municipal Code, entitled “Permitted uses” is revised to include the following subsection: M. Transitional and Supportive Housing, when such a use is in a single-family dwelling and subject to the same standards as may be required for dwellings in this zone.

SECTION 5. Code Amendment. Section 17.24.020 of the Municipal Code entitled “Permitted uses”, is revised to include the following subsection: E. Transitional and Supportive Housing, when such a use is in a two-family dwelling and subject to the same standards as may be required for dwellings in this zone.

SECTION 6. Code Amendment. Section 17.28.030 of the Municipal Code entitled “Permitted uses”, is revised to include the following subsection: E. Transitional and Supportive Housing, subject to the same standards as may be required for dwellings in this zone.

SECTION 7. Code Amendment. Section 17.30.030 of the Municipal Code entitled “Permitted uses” is revised to include the following subsection: E. Transitional and Supportive Housing, when such a use is in a single-family dwelling and subject to the same standards as may be required for dwellings in this zone.

SECTION 8. Code Amendment. Subsection 17.36.020(f) of the Municipal Code entitled “Residential Uses” is hereby amended to read: Residential uses, including transitional and supportive housing, other than on the ground level, which are consistent with the standards of Chapter 17.28 of this code and any alterations to those standards as may be approved pursuant to a permit issued under this chapter, and except as otherwise provided for parcels subject to Chapter 17.35.

SECTION 9. Code Amendment. Section 17.52.070 of the Municipal Code entitled “Land use regulations” is revised to include the following subsection: 3. Transitional and Supportive Housing.

SECTION 10. Code Amendment. Section 17.40.010 of the Municipal Code entitled “Permitted Uses”, is revised to include “emergency shelters”.

SECTION 11. Code Amendment. Section 17.40.025 entitled “Emergency Shelters Development Standards” is hereby added to the Municipal Code as follows:

1. Property Development Standards. The emergency shelter shall conform to all property development standards of the M Zone except as modified by these development standards.
2. Maximum Number of Persons/Beds. An emergency shelter for homeless persons shall contain no more than 8 (eight) beds and shall provide shelter for no more than 8 persons. Additionally, the cumulative total number of beds permitted in the M Zone shall not exceed 8 (eight). Such maximum number may be accommodated in multiple shelters not to exceed the cumulative total.
3. Parking. On-site parking shall be provided based on the following standards: 1(one) parking space for every 4 beds, plus ½ space designated for each bedroom designated for families with children, plus 1(one) parking space for each employee or volunteer on duty, plus 1(one) space for every vehicle operated by the facility.
4. Lighting. Adequate exterior lighting shall be provided for security purposes. The lighting shall be stationary and designed, arranged and installed so as to confine direct rays onto the premises and to direct light away from adjacent structures and public rights-of-way. External lighting shall be of intensity compatible with the neighborhood.
5. Common facilities. The emergency shelter may provide one or more of the following specific common facilities for the exclusive use of the residents:
 - (1) Central cooking and dining room.
 - (2) Recreation room.
 - (3) Laundry facilities to serve the number of occupants in the shelter.
 - (4) Other uses that are considered as ancillary to the primary use such as office, storage.
6. Onsite staff. At least one manager shall be onsite during all hours of operation of the facility. Such manager must be an individual who does not utilize the shelter’s beds or other services and who resides off-site.
7. Security. Security personnel shall be provided during operational hours whenever clients are on the site. Security personnel are in addition to the staffing requirements in subsection (5). A security plan shall be submitted to the City prior to the issuance of a certificate of occupancy.
8. Concentration of Uses. No more than one emergency shelter shall be permitted within a radius of 300 feet from another such emergency shelter.
9. Emergency Shelter Operations. The agency or organization operating the emergency shelter shall comply with the following requirements:
 - (1) Each emergency shelter resident shall stay for no more than 90 days (cumulative, not consecutive) in a 365-day period. Extensions up to a total stay of 180 days in a 365-day period may be provided if no alternative housing is available.
 - (2) On-site client waiting and intake areas shall be located inside the building.
 - (3) The provider shall provide an annual report of the use of the facility and determination of compliance with the City’s development standards for the use.

SECTION 12. California Environmental Quality Act. The City Council has considered all of the evidence in the record, including the staff reports, the testimony received during the public hearing on the matter held by the Planning Commission and City Council, and hereby determines that the Initial Study prepared for the 2008-2014 Housing Element in accordance with the City’s guidelines implementing the California Environmental Quality Act (CEQA) was undertaken for the purpose of deciding whether the housing program objectives identified in the Housing Element to fulfill the City’s RHNA allocation may have a significant effect on the environment. Therefore, the City Council concludes that the proposed amendments will not have a significant effect on the environment.

SECTION 13. Severability; Continuation of Provisions. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases of this Ordinance or the rules adopted hereby. The City Council of the City of Sierra Madre hereby declares that it would have adopted each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that any one or more other remaining sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases hereof be declared invalid or unenforceable. ORDINANCE 1351

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SIERRA MADRE, CALIFORNIA AMENDING SECTION 13.08.020 OF THE SIERRA MADRE MUNICIPAL CODE REGARDING SEWER RATES AND ADOPTING WATER AND SEWER RATE SCHEDULES

WHEREAS, the City provides water service pursuant to Chapter 13.04 of the Sierra Madre Municipal Code, WHEREAS, Section 13.04.060 provides for the approval of a water rate schedule pursuant to Article XIIID, Section 6 of the California Constitution; WHEREAS, the City provides sewer service pursuant to Chapter 13.08 of the Sierra Madre Municipal Code, WHEREAS, by prior action the City Council proposed to increase the rates charged for water and sewer service; WHEREAS, notice of the proposed rate increases and of a hearing thereon, was mailed pursuant to Article XIIID, Section 6 of the California Constitution; WHEREAS, a full and fair public hearing was held on January 28, 2014, at which all interested persons were permitted to present oral and written testimony with respect to the proposed increased rates;

WHEREAS, protest ballots received by the city up to the close of the public input portion of the public hearing have been tabulated in a location accessible to the public by impartial persons designated by the agency who do not have a vested interest in the outcome of the proposed water rate and sewer rate increases; WHEREAS, the protest ballots have been unsealed and tabulated in public view to permit all interested persons to meaningfully monitor the accuracy of the tabulation process; WHEREAS, following the public input portion of the public hearing and tabulation of the ballots it is found that a majority protest does not exist;

THE CITY COUNCIL OF THE CITY OF SIERRA MADRE DOES HEREBY ORDAIN AND RESOLVE AS FOLLOWS:

- Section 1. Section 13.08.020 is hereby amended to read as follows: 13.80.020 Sewer Rates The City shall adopt a schedule of sewer rates pursuant to Article XIIID, Section 6 of the California Constitution
- Section 2. The rate schedule set forth in Exhibit "A" to this Ordinance is hereby approved as the schedule of water rates for the City.
- Section 3. The rate schedule set forth in Exhibit "B" to this Ordinance is hereby approved as the schedule of sewer rates for the City.
- Section 4. The City Council may annually consider the rates set forth in Exhibits A and B and may, by Ordinance, reduce or delay the effectiveness of any scheduled rate.
- Section 5. The City Council directs that the Utility Users Tax imposed by Section 3.36.090 shall be collected at a rate of 8 % beginning with the effective date of the rate increases, unless modified by subsequent ordinance, resolution, order, or municipal election rescinding this direction effective as of any date subsequent to the adoption of that ordinance, resolution, or order. Such rescission shall not be interpreted as an increase of the rate of the Utility Users Tax for purposes of Articles XIIIa or XIIC of the California Constitution. Notwithstanding any other provision of this Ordinance, the Council would not have adopted any portion of this Section if any other portion of this Section were invalid or unenforceable and the provisions of this Section are not intended to be severable from each other.
- Section 6. The City Council finds as follows:
- A. The purpose of the City's water rates is to fund costs associated with providing water service to the customers in the City
 - B. The revenue from the water rates will not be used for any other purpose and will not exceed the funds required to provide water service.
 - C. The amount of the water rates, and of the Water Connection Fee (Bi-Monthly Meter Charge), imposed upon any customer does not exceed the proportional cost of service attributable to the customer.
 - D. The purpose of the City's sewer rates is to fund costs associated with providing sewer service to the customers in the City
 - E. The revenue from the sewer rates will not be used for any other purpose and will not exceed the funds required to provide sewer service.
 - F. The amount of the sewer rates imposed upon any customer does not exceed the proportional cost of service attributable to the customer.
- Section 7. If any section, subsection, subdivision, paragraph, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases hereof, irrespective of the fact that any one or more of the sections, subsections, subdivisions, paragraphs, sentences, clauses, or phrases hereof be declared invalid or unenforceable. Rates for each subsequent fiscal year shall automatically take effect on July 1 of that fiscal year.
- Section 9. The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published according to law.

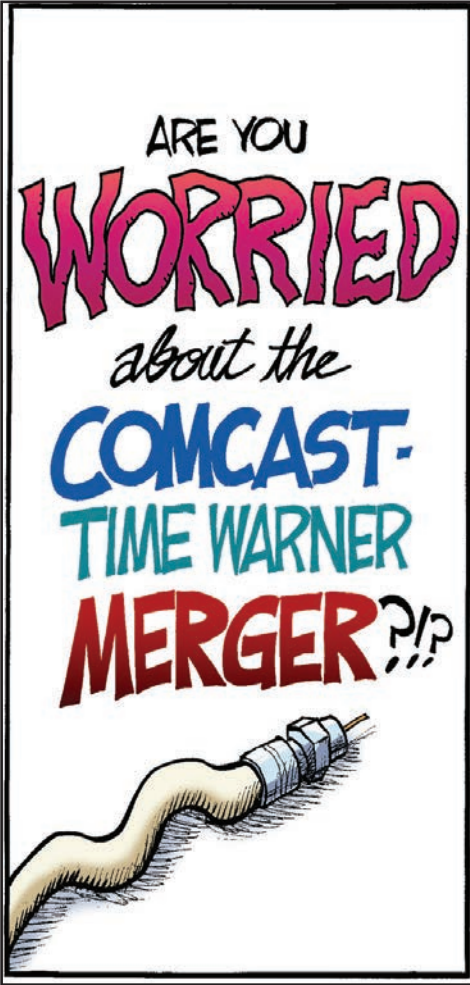

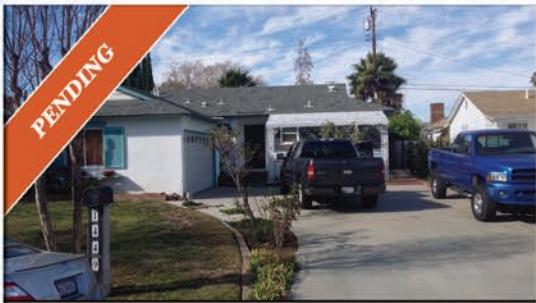

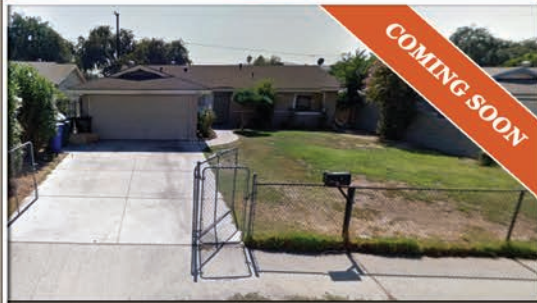
