Sierra Madre is getting a new resident. The Cancer Support Community Pasadena in moving in.

CSC, an organization which currently provides ten weekly support groups and one monthly support group facilitated by professional mental health therapists, and over 125 monthly education workshops led by experts in their field along with stress management classes plans to move to Sierra Madre in April, 2023.

The Cancer Support Community organization was established in 1982, Harold and Harriet Benjamin transformed the way our culture faces cancer. Har-riet, a cancer survivor herself, sought to create an organization that would provide social and emotional support to not only cancer patients, but also to families, friends, and caregivers. The Benjamins strongly encouraged psychosocial care because they believed in a strong correlation between emotional and physical well-being. Thus, the first walk-in community facility of its kind, The Wellness Community (TWC), was founded in Santa Monica, CA as an outlet for those suffering from cancer to receive appropriate support.


esistant as well as drought tolerant.

AGAIN, NO **DISCRIMINATION**

Let's get some facts straight about the November Initiative Measure

The Initiative only changes the Zoning designation of the Mater Dolorosa Property from "Institutional" to "Hillside Management".

The Initiative does not require any amendment to the existing Sierra Madre Municipal Codes to enable its provisions.

Once the Initiative is adopted, the provisions of the Sierra Madre Municipal Code kick in, and the existing structures on the Mater Dolorosa Property automatically become "non-conforming" due to the change of the zoning designation of the Mater Dolorosa Property.

The Sierra Madre Municipal Codes allow the Passionists to continue to use its existing structures in their current form, and also allow changes and additions to its structures as long as there is compliance with guidelines provided in the Sierra Madre Municipal Codes.

There has been a lot of discussion that the Initiative is subject to legal challenge on the grounds that it results in religious discrimination against the Passionists or otherwise constrains the mission of the Passionists. Any such discussion is misguided.

Under the Initiative, the Monastery Property will be rezoned as a Hillside Management Zone. If the trail of SMMC Section 17.52.070 C (1) of the Hillside Management Zone is followed, one arrives at Section 17.60.030 (A) which clearly states, that "Churches, temples and other places of worship" are uses that are permitted in basically all zoning classifications, including the Hillside Management Zone.

The purpose of allowing "Churches, temples and other places of worship" in virtually all zones within the City is to ensure that there no discrimination against the free practice of religion in Sierra Madre, including the building of churches, temples and other places of worship in essentially all zones that are occupied by people.

The Sierra Madre Municipal Codes have clearly been drafted so as not to run afoul of existing federal and state laws, including the Religious Land Use and Institutional Persons Act ("RLUIPA"). Any conclusion that the Initiative prohibits the right of a religious organization to exercise its religious freedoms is blatantly incorrect.

All that the Initiative does is change the zoning of the Mater Dolorosa Property from Institutional to Hillside Management. The City of Sierra Madre, or the people through an Initiative, have the right to re-designate the Monastery Property from Institutional to Hillside Management, absent a prohibited restriction. From that point on, the existing provisions of the Sierra Madre Municipal Codes can be relied upon to protect against religious discrimination from occurring. To suggest anything different would be to conclude that the City of Sierra Madre Municipal Codes are defective. If they are defective, then any unintended consequences from the adoption of the Initiative cannot be blamed on the Initiative, but rather on the defects that may be embedded in the City of Sierra Madre Municipal Codes, if they exist.

Perhaps the confusion regarding the claim of religious discrimination rests with the following language contained in the City's Memorandum dated July 8, 2022 from the City Attorney to the Mayor and Councilmembers. The Memorandum states that if a zoning district is silent as to prohibited uses, it is considered prohibited if it is not expressly permitted. The Memorandum on Page 11 goes on to examine the Sierra Madre Municipal Codes and concludes that "since a retreat center and religious depictions are not listed as permitted or conditionally permitted uses, they are prohibited in the Hillside Management Zone."

We are not sure why that conclusion was reached.

As noted above, the language of Section 17.60.030 (A) of "other places of worship" is unquestionably a broad and all-encompassing enough term that certainly includes a religious "retreat center" and "religious depictions". The City would be wrong to deny any requests from the Passionists to build or improve such structures on the pretense that they are not allowed.

The conclusion in the City's Memorandum that the Hillside Management Zone prohibits structures relating to places of worship affects many other arguments in the Memorandum. If churches, temples and other places of worship are permitted in the Hillside Management Zone, then all of the other conclusions noted in the Memorandum that deny this fact fall by the wayside.

So again, why does the Memorandum of the City Attorney dated July 8, 2022 reach the conclusion that the Monastery cannot build a church, temple or other place of worship on its property if its property is designated as Hillside Management, when the language of our Municipal Codes allows for such structures? This question has been posed to the City on many occasions and those questions have not even merited the courtesy of an acknowledgement of receipt by the City.

We patiently await the City's reply!

GRASSHOPPERS AND CATTLE

In the Mountain Views News July 23rd edition's column by Preserve Sierra Madre discusses the report to City Council with a recap: ". . . the Passionists, who own the Monastery property, have entered into an agreement with a developer, New Urban West (NUW) to sell 20 acres of their property. . . . "A citizens' petition to place the 20 acres in the Hillside Management Zone (HMZ). . . . was under discussion."

Note: the entire 35 buildable acres owned by Mater Dolorosa would be placed in the HMZ.

The column goes on to argue that the City Attorney made major errors in his report and the Council Members had faulty reasoning to challenge the initiative, and the council meeting was in "total disregard of the input of 1300 residents. .

Protect Sierra Madre in that same paper asks "Who Does Our City Council Represent?" Bottom line "It's one thing for residents to have to deal with an unscrupulous developer who will go to any means to get this project approved, but quite another when we can't trust our city council to stand up for its residents and essentially tell 1,300 constituents, ... we know better than you."

There is an old saying that goes like this, "Because half a dozen grasshoppers under a fern make the field ring with their importunate clink, whilst thousands of great cattle reposed beneath the shadow of the British oak, chew the cud and are silent, pray do not imagine that those who make the noise are the only inhabitants of the field." -William Blake.

The City Council Members in all their wisdom decided to oppose Measure HR and in fact, write a ballot argument against it. The five members of the council are all educated, intelligent citizens elected to do what is best for Sierra Madre and its Citizens. They get feedback not only from grasshoppers but also from the cattle in the field. Council did read the Initiative and all have the ability to make an informed decision. Our Council Members are upstanding members of the community and it is an insult to imply they are otherwise.

The Council debated on the merits of the Initiative. They had no say on the merits of the NUW proposal. They are concerned about Measure HR taking away the rights of property owners and of it setting a dangerous precedent of taking away land rights. The Council IS looking after their residents and are fighting against a poorly written, sloppy initiative, and protecting the rights of property owners who apply to the city for a zoning change.

HERE COMES THE BUS AGAIN

When the ill-conceived ballot initiative to rezone the Monastery property first reared its ugly head the proponents made an odd claim. In their infinite wisdom, they divined that, "Residents of Sierra Madre are no longer confident that enforcement of those policies and goals in our General Plan are a priority of our City Council..." One has to wonder how they came to this grand conclusion when the city council has yet to receive an action item on the Meadows

While supporters of Measure HR had been unfairly critical of the City Council, this was the first time they had firmly pushed them under the bus. This is despite claiming this week that they "...do not throw anyone under the bus for disagreeing with our position." Then we think it is fair to ask why they do it.

In a rare social media commentary where they allowed dissenters to respond, the proponents said that they support the Planning Commission because they have "read and analysed [sic] and questioned [... and ...] responded to comments". But their complaint with the City Council is that "they usually accept the recommendations [...] without considering any other arguments or the opinions of their constituents." Last time we checked the City Council was mandated to allow public comment at every meeting. Can you see the bus coming?

In another claim their spokesperson said, "But I DO not support their inferring to the people that theirs is an informed and well studied opinion and that the people should accept it when it is NOT!" What is the basis for this claim? How do they know what individual city council members have or have not studied? We suppose facts do not matter when the foundation of accusations is to just push the City Council under another bus.

In another accusatory attack, they say, "...when we see [the city Council] make decisions based on someone elses [sic] recommendation [...] we dont [sic] feel they are adequately representing the constituents they have all PROMISED to represent." What they seem to be saying is that they don't like when the conclusion differs from their own. If someone's recommendation is sound then the City Council should accept it, right?

Here is where the issue gets tricky. The Planning Commission's job is to evaluate the Meadows project and to make a recommendation to the City Council. The proponents accept that the Planning Commission has fairly assessed the Meadows project, but somehow the City Council is not allowed to accept the Planning Commissions educated conclusions without it being biased and uninformed. Why discuss the facts when one can keep pushing the City Council under every bus?

The proponents' answer to the City Council supposedly not having made an informed decision is to put the decision to a vote of the electorate. How does that result in a more informed decision? Why believe that the average voter knows anything at all about the Meadows project? What we do know is that the proponents spoon-fed lies to voters when they collected their 1300 signatures. 



A fabulous Monarch butterfly, triumphantly emerged and gearing up to spread his wings and fly. This is Leah's second success as her first chrysalide, Larry, also made it to butterfly-hood. There

has been much heartbreak as Linda and Leo struggled to emerge but did not succeed. This picture, courtesy of Chuck Seitz, shows details of Lucas' wings that sent him/her so quickly upward when the door was opened. This is truly a miracle!

Here's a little Wikipedia to help you understand what's happening in Leah's milkweed garden:

"To prepare for its chrysalis stage, the caterpillar chooses a safe place for pupation where it spins a silk pad on a downward-facing horizontal surface. It then turns around and securely latches on with its last pair of hind legs and hangs upside down, in the form of a letter "J." (This is best case scenario as they don't always do that, frequently attaching themselves to the bottom of the cage, the zipper or someplace else completely inappropriate.) After "J-hanging" for 12-16 hours, they straighten out their bodies and go into peristalsis some seconds before the skin splits behind its head. It then sheds its skin and little by little turns into a gorgeous butterfly."

Still ahead, Lorraine, Lorenzo and Lulu will either live or die. This process takes an eternity! 11-12 days. I admire Leah tremendously for taking on this project. As she is having her kitchen remodeled, she can't go anyplace anyway, so observing this life and death struggle has been a good preoccupation as the kitchen remodel takes longer and longer. Any of you who have had a kitchen or bathroom remodel will understand completely. We had our bathroom remodeled some years ago and I thought I'd never get the plaster dust off of everything. Yes, it's beautiful when it's finished but it makes you crazy while it's going on.

Of course, I am reminded of what a bad day really looks like: On August 24th, A.D. 79, long-dormant Mount Vesuvius erupted, burying the cities of Pompeii and Herculaneum in volcanic ash; an estimated 20,000 people died. Worse than plaster dust.

Friday was VJ Day (1945) and this is Labor Day weekend!!


"Labor Day is a great opportunity to reflect on what you failed to accomplish this summer."



September Is Pedestrian **Safety Month**

As part of Pedestrian Safety Month, the Pasadena Police Department announced Friday that they will participate in activities throughout September encouraging the safety of

people walking.

"People should not feel in danger walking," Pasadena
Police Department Lieutenant Anthony Russo said. "Drivers, please slow down and be aware of people who are walking. If we all look out for one another, we can all get where we need to go safely." Based on data projections from the Governors Highway Safety Association (GHSA), 7,485 people, or an average of 20 people every day, died after being struck by a vehicle last year - an 11.5% increase from 2020 and a 40-year high. To promote the safety

of people walking, the Pasadena Police will conduct a traffic safety operation on Sept. 16 focused on the most dangerous driver behaviors that put the safety of pedestrians at risk. These violations include speeding, making illegal turns, failing to yield and running stop for signs or signals.

The Pasadena Police Department offers safe driving and walking tips, including staying off the phone when behind the wheel or walking: Drivers

-Do not speed, and slow down at intersections. Be prepared to stop pedestrians marked and unmarked crosswalks.

-Avoid blocking crosswalks while waiting to make a right-hand turn.

-Never drive impaired. Pedestrians

predictable. signalized crosswalks where drivers may anticipate foot

-Watch for approaching vehicles and practice due care crossing the street. At 30 mph, a driver needs at least 90 feet to stop.

-Make it easier for drivers to see you at night – wear light colors, reflective material and use a flashlight.

-Be careful crossing streets or entering crosswalks at night or on busier streets with higher speed limits. For more information visit:

Water & Power Tests New Grid Reliability Project

General Manager of Water and Power announced that earlier this month, Pasadena Water and Power ("PWP") successfully tested new equipment that may reduce power disruptions in the future.

PWP receives most of its power from power generation plants and renewable power facilities located outside the City. The power is sent to the direction of the California ("ISO"). In August 2020, the utilities, including PWP, to curtail load because they had a heat and power system issues. Utilities typically achieve load curtailment by turning off a portion of their customers for an hour, and then rotating the outage to another set of customers until the situation is



IRWINDALE'S NEW POLICE CHIEF ROB CASTRO

The City of Irwindale has a new Police Chief, Rob Castro, who has 33 years of law enforcement under his belt. His career began at Glendora Police Department in 1985; promoted to Sergeant in 1995; Lieutenant in 1999; and Captain in 2004, managing daily operations and budget for the entire department. In January 2011, he was chosen as Glendora's Chief of Police. Hs tenure there was outstanding as his peers selected him as Officer of the Year in 1991 and 2000.

At Azusa Pacific University Castro graduated Magna cum Laude in 1997 (Bachelor of Science degree in Applied Business Management) and a Master's Degree in Business Management in 2005. He also graduated from West Point Military Academy Law Enforcement Leadership Program and from California PPST Command College.

During his 33 year career in law enforcement, Castro worked many assignments; four years as a narcotic detective (three undercover apprehending major narcotic cartels) in Glendora. His partner and close friend, Glendora Detective Louie Pompei was killed in the line of duty in 1995.

After a nationwide search, the City of Glendale swore in Rob Castro as their Chief, assuming command of the third largest police department in L.A. County with a department of 500 personnel. Chief Castro created the only independent municipal police crime lab and provided crime lab services to police agencies throughout California. Chief Castro developed an Emergency Medical Technician program in Glendale with 40 EMT police officers, two Paramedic police officers and trained two hundred officers as Field Tactical Medics, the first of its kind in Los Angeles County. Hundreds of lives were saved as police officers often are on the scene first at many dangerous situations.

Chief Castro has focused police department resources to address homeless issues, traffic safety and technology advancement. He believes all employees are an organization's most important resource for a police chief. Chief Castro attended patrol and special operations briefs to support his troops and trained and worked with his patrol, division, helicopter operations unit, bicycle patrol investigative divisions and K-9 teams

For their Police Chief, the City of Irwindale has chosen Rob Castro, who is surely very experienced and qualified.

NATIONAL 988 SUICIDE & CRISIS LIFELINE

Nationwide, people who are experiencing a mental health crisis and in need of immediate help are now able to dial or text 988 and receive assistance through the new Suicide and Crisis Lifeline number.

A new 988 Call Center, operated by Didi Hirsch, is now taking calls coming into the 988 hotline in Los Angeles County. Trained operators are available to triage callers to receive the appropriate services, including suicide crisis counseling over the phone and mental health de-escalation counseling over the phone. In addition, they will also triage callers to determine when dispatching a mobile crisis team is appropriate and, in rare cases, connection to law enforcement when safety is of concern.

Happy Tails

I was inspired to re-submit this previously-printed article, after hearing about a hiker rescued on Mount Wilson last week. In an interview, the hiker admitted the mishap was his own fault. He'd let his bulldog puppy tag along with him on the trail, without a leash! Not at all surprisingly, the pup wandered a few feet away and fell off the trail, so he scrambled after the dog, lost his footing and ended up on a ledge, thereby becoming yet another lucky beneficiary of the hard work and honed skills of

search & rescue responders. Here's the article. I hope the people who need it, read it.

LOVE 'EM & LEASH 'EM

Growing up in the deep south, I was fortunate to have had lots of animals in my life throughout my childhood. I remember enjoying the luxury of letting our dogs roam free, confident that they'd have fun wandering in the woods behind our house and visiting the neighbor's dogs, then eventually return home in time for supper. It was quite a privilege to have had such freedom back in those days, and I imagine there are lots of people my age who have similar childhood memories. With oodles of undeveloped land, ample space between homes, and a heck of a lot less traffic passing through the neighborhoods, the risks were minimal for a kid or a pet who wanted to explore the great outdoors. It just seemed natural then, right?

Well, it's 2022 now folks, and the open acres, natural spaces and lush land gaps that existed in the 1960's and '70's have shrunk dramatically in most parts of America. Few and far between are the moments of silence without swiftly passing vehicles on the boulevards and streets where we live. And ever-so-rare (rarer by the day) do we find undeveloped fields, or ample spaces between. Let's face it, free-range pet ownership in our "neck-of-thewoods" is far-and-away long-gone. Not only is it too risky to allow a domestic dog to run around off-leash, it is also against the law in LA County. Even pet owners in our "village" should know better.

I learned my own lesson about the importance of using a leash several years ago, while living in Hermosa Beach with my dog, "Lady". She was such a friendly pup, I was never concerned that she might get into a doggie tussle, or hurt anyone. I loved to let Lady play on the sand and follow along while I rode my bike on the strand, particularly during the off-season months when there was less traffic and fewer tourists in town.

One day I let Lady saunter along when I went to get coffee at the local breakfast nook and a cop cited me for having her off-leash. The leash law was new to me, so I was more than surprised when I was told I had to take a day off work to appear in court and pay a hefty fine. That was the last time I allowed my dog to roam off-leash outside the perimeters of a fenced-in space. Though I admit it seemed ridiculous at the time, I've since learned to respect the leash law, and I've become somewhat of a compliance advocate, for the sake and safety of the animals. To me, it's just simple common sense.

While we would all love to assume that our own dog is smarter than the others, it is not a safe assumption. First of all, you never know what the "other guy" might do. And secondly, it only takes a matter of seconds, for a tragic accident to happen. Ultimately, allowing your dog to roam off leash where we live, here in the foothills, whether on the street or on a trail, amounts to nothing less than pure negligence.

A domestic dog is still a creature driven more by instinct than allegiance to it's master, regardless of how much training is involved. In fact, the human's delusion of owning the perfectly obedient dog is an excellent example of how, in some ways, the dog is far smarter than the human. Sadly, though, a dog's intelligence is typically not aligned in a way that will protect him from human ignorance.

I mean no offense to those responsible owners who've taken the time to properly train their pets. In fact, I want to encourage you responsible pet owners to keep up the good work! It's just that in a moment of urgency, a canine will most likely do what comes naturally to itself, and much of the time that canine instinct is not in tune with what a human might or might not do, particularly when an oblivious human is behind the wheel of a fast-moving


Even a well-trained, aware and obedient domestic dog will have a tendency to default to nature. Meaning, he or she may chase a squirrel scrambling up a tree, a bird taking flight or a cat meandering on the opposite side of the road. And when that happens, the dog's instincts are likely to override any obedience training it may have had, prompting it to take chase after whatever caught it's attention.

It only takes once for a car to come flying by at the wrong place and wrong time, to end the life of a precious pet. So I say, please set your "smart pet pride" aside, and take proper precautions. The risks are never worth it and it would be you, not your dog, to blame if such a tragedy should happen. The 'I'm so sorry' afterwards won't fix it. A loving, caring pet owner will always protect their pet from harm, and that kind of unconditional love includes educating oneself and forfeiting some of the freedoms we used to enjoy, such as roaming off leash, like in the good old days. If you love them, you will leash them!

UNUSUAL EXPERIENCES WITH SOUND

I've observed that higher pitches travel longer than lower pitches, which I think is fairly well accepted, especially as it pertains to whistles.

I've also observed that sound seems to travel horizontally. I know that doesn't sound right, but various experiences have demonstrated to me the horizontalness of sound. When I lived in Highland Park, the neighborhood street ran east to west through the low spot in the hills, and the houses were set back on both sides. I lived on the south side of the valley, and to get up to my home, I had to walk 51 steps.

One early Sunday about 7 a.m., I had planned to visit my neighbor, who lived across the street, about level with my house. You walked up a driveway 1/10 of a mile, uphill, to get to his place. I was outside my home before I departed, and though everything was very quiet, I noticed some people talking. Probably two people. I paused and listened. Who could that be, and from where? Amazingly, I was listening to the two people I was going to visit across the street, and they were apparently on their own back porch. Our homes were about 1/5 of a mile apart, and I then realized that both our back porches were on the same horizontal level. I listened. I could distinctly make out their words! I don't recall ever hearing anyone with such clarity that far apart. In fact, I don't ever recall hearing with clarity people who were just down on the street from me, much closer. I did "cheat" a bit, and I cupped my hand around my ear in the direction of the sound, something I learned years earlier. I could hear their conversation with much greater clarity.

When I walked down my 51 steps, and then up the 1/10 of a mile driveway, my two neighbors were there still talking when I arrived. I told them what I heard them saying some 15 minutes earlier. They looked at me in disbelief, as if I was making it all up. "That's impossible," Prudence told me. "You were hiding back there behind the bushes, right?'

"No!" I told her. But I am pretty sure they never believed me.

Whatever I experienced could have been an anomaly, but ever since I have taken note of the horizontality of sound waves, keeping in mind that other factors – such as the landscape and wind – can also affect sound.

On another occasion, I was walking in a long narrow canyon where a small stream flowed. The can-yon meandered north to south, and there were tall stony walls to the canyon. The stream trickled over rocks that clinked back and forth as the water flowed along. While pausing to eat an apple, I heard it. It sounded like three or four people chattering away, just around the next bend upstream. I got up and curiously walked upstream to see who was there. I listened carefully to the conversation, trying to make out the words. The people must have been walking upstream, since when I got around the next bend, no one was there but I still heard them.

It was not English, I thought. Not Spanish. I listened carefully as I walked. Maybe Mandarin? Maybe

Bend after bend, I saw no one. Then I decided to start looking at the footprints and to my amazement, I saw none! I ran briefly, trying to catch up with the elusive hikers. But no one was there. I was baffled! What was I hearing?

After sharing this experience with others, I was led to Craig Childs' book, "The Secret Knowledge of Water." Childs describes a nearly identical experience in a slot canyon in the desert Southwest where he hears voices of people talking where there was only water trickling through a narrow canyon. Were we each hearing what we wanted to hear? Was it a unique fluke of nature?

I never heard a precise explanation for this phenomenon but it's something I never forgot – phantom voices springing from the canyon streams.

3 ESTATE PLANNING CONCERNS FOR MARRIED, SAME-GENDER COUPLES

Now that same-gender couples can legally marry in all 50 states, more Americans than ever before are enjoying the rights and benefits that come with mar riage. Estate planning is one arena where these new rights and benefits are readily

Absent a plan for incapacity, it's left to the court to appoint the person who will make these decisions for you. Though spouses are typically given priority, this isn't always the case, especially if unsupportive family members challenge the issue in court. To ensure your spouse has the authority to make decisions for you, you must grant him or her medical power of attorney and financial power of attorney.



HOW THE INFLATION REDUCTION ACT WILL LOWER YOUR **DRUG COSTS**

Dear Savvy Senior:

What kind of changes can Medicare beneficiaries expect to see in the Inflation Reduction Act that was recently signed into law? I'm enrolled in original Medicare and have a Part D prescription drug plan but spent more than \$6,000 out-of-pocket last year on medications alone. Overpaying Paul

Dear Paul:

The climate, tax and health care bill known as the Inflation Reduction Act that was passed by Congress and signed into law by President Biden last month includes significant improvements to the Medicare program that will kick-in over the next few years.

These changes will lower prescription drug prices for millions of seniors by allowing the government to negotiate drug prices for the first time and capping seniors' out-of-pocket drug costs at \$2,000 annually. Some other popular changes will include free vaccinations, lower insulin costs and expanded subsidies for lower income seniors.

Here is a breakdown of the changes to expect in Medicare and when they will roll out.

2023: Starting this January, all vaccines covered under Medicare Part D, including the shingles vaccine, will be free to beneficiaries. And the skyrocketing cost of insulin will be capped at \$35 per month. This will be a significant saving for the more than 3 million Medicare enrollees who currently use insulin to control their diabetes.

Also starting next year, drug makers will be penalized in the form of "rebates" that they would be forced to pay to the government if they impose price increases that exceed general inflation.

2024: Cost sharing for catastrophic coverage in Part D will be eliminated. Under the current Part D benefit, once your out-of-pocket costs reach \$7,050 in 2022, you enter "catastrophic" coverage but are still responsible for 5 percent of your prescription drug costs, with no limit.

But in 2024, people with Part D coverage will no longer be responsible for any out-of-pocket drug costs once they enter catastrophic coverage. This is significant for seniors who use expensive medications for conditions like cancer or multiple sclerosis.

Also starting in 2024 through 2029, Part D premiums will not be allowed to grow faster than 6 percent per year.

And for lower income Medicare beneficiaries, eligibility for the Part D Low Income Subsidy (also known as Extra Help) will be expanded to 150 percent of the federal poverty level, from today's limit of 135 percent. This change will mean about 500,000 more seniors will qualify for financial assistance to help pay some or all of their prescription drug premiums and deductibles.

2025: One of the biggest cost reduction measures for Medicare beneficiaries will begin in 2025 when out-of-pocket spending on Part D prescription drugs will be capped at \$2,000 per year. This will be a major savings for the more than 1.5 million beneficiaries who currently spend more than \$2,000 out-of-pocket each year.

2026: When Medicare's Part D program was enacted in 2003, negotiating lower drug prices was forbidden. But because of the Inflation Reduction Act, starting in 2026 Medicare will be empowered to begin negotiating prices with drug companies for 10 of the most expensive drugs covered under Part D. In 2027 and 2028, 15 drugs would be eligible for negotiations and in 2029 and subsequent years, 20 drugs would be chosen.

And, in addition to all the Medicare improvements, the Inflation Reduction Act also extends the Affordable Care Act (Obamacare) premium subsidies for three years that have helped millions of Americans gain coverage before they're eligible for Medicare.

PUT THE LIGHTS ON



Right now my IPhone says the temperature outside is 100 degrees and I admire anyone who is walking around out there when they don't have to. I, in my air conditioned bedroom, have spent the day watching the U.S. Open tennis matches. Just now I saw Venus, age 42, the older of the Williams sisters, lose what might well be her final singles match after turning professional at age 14. As most of you know, after seeing the award winning "King Richard" Movie, Venus and her sister grew up in Compton. This is a place in what was then called South Central Los Angeles, right next to Watts. (In 2003 the Los Angeles City Council voted to officially replace the name "South Central Los Angeles") the places may have been changed but the neighborhoods character

and reputation remain the same.

Let me describe my major impression of Watts to you. In 1966 while in Law School I ended up with a work-study job helping to create a program which brought Hispanic students from Boyle Heights and African-American students from Watts and Compton to UCLA to live in the dorms for the summer. As the student-coordinator I was allowed to reside in the dorm with the male students. I think the program was a life-changing experience for many of the students; it certainly was for me. In the program there was a brother and sister who lived in a Watts apartment. We received a call that there was some sort of emergency at the kids' home. A few staff members and I accompanied the kids who were 15 or 16 to their apartment. When we got there a crowd and some policemen were gathered around the house and as we all walked towards the open door of the apartment someone from the crowd yelled, "Sorry Whiteman, she's closed for the night." Almost at the same moment we saw, the kids and staff members, we all saw their murdered mother lying on the apartment floor. I looked away as soon as I could but the horror remains in my mind as a fitting description of Watts.

In the movie Venus and her sister Serena are shown playing tennis under the watchful eye of their father. Playing, or practicing on the cracked concrete courts with broken wire nets separating one side from the other. Their father, who was not a tennis player, hatched an idea after seeing female professional tennis players receiving large checks that he could oversee his daughters to do the same thing. Of course the White female players were not only of a different race, they were from a completely different social class. At the time there were no African American(all right they were called Black then) on the professional tour but amazingly they both made the big time and are both considered to be among the best female players in history. (Actually Serena is generally recognized to be the all- time greatest.) I don't know if their abilities were compared in the movie because to be truthful I have difficulty watching movies about sports heroes which seem like glamographies, hardly truthful and overly dramatized such that I don't pay much attention.

Anyway this article is not about the movie, it is about Venus. Venus is an amazingly supportive, complicated person. All along her father was telling all who would listen that Venus would win a major championship but his younger daughter Serena would be acclaimed as the best player of all time. Remarkably the younger sister did win a Major Championship, the U.S. Open in 1999. I think I remember seeing Venus absolutely thrilled by her sister's victory as she stood snapping pictures of her. Actually, this might have been after another Serena victory during which she defeated Venus. In fact in one year Serena defeated Venus in the final of all 4 major championships and Venus always seemed overjoyed by her sister's victories.

By this description it may sound as if Venus is a self-effacing person easily dominated by others. Anything but! She has a remarkable record of her own victories together with as record for longevity. Venus has been the major force demanding that female players receive comparable compensation as do the men. After being racially insulted at the annual Southern California tournament held at Indian Wells near Palm Springs, Venus and Serena both boycotted the tournament for a few years depriving the sponsors of attendance revenues. Originally Venus and Serena were criticized for not being committed enough to the game. It was predicted that after their original early success they would fade from view succumbing to destructive pressures and pleasures of celebrity hood. This is exactly what happened to teenage champions like Jennifer Capriati and Mary Pearce. This year the number one female player, Ashleigh Barty has retired explaining that the pressures and expectations made continuing too much of a burden. Recently young players like Naomi Osaka and Coco Gauff have missed tournaments and complained about depression and emotional pressures.

Over the years Venus has been afflicted by some chronic disease which has sapped her energy, her older sister was murdered in Los Ángeles, her parents have separated. Nevertheless Venus has matured into being on her own a very successful business-woman and a political spokesperson. She lost the match today, but will play doubles tomorrow or the day after with Serena as her as her partner. Win or lose she is a person to be admired and it's hard to find such people these days.

BIDEN'S PHILLY SPEECH WAS A CHALLENGE TO ALL OF US



Returning to the state where he launched his candidacy and the one that handed him the White House in 2020 — President Joe Biden on Thursday called on Americans to join him in a fight to preserve democracy and to beat back the forces of extremism.

The 30-minute address was equal parts tribute to the nation's resilience and a wartime call to arms from a president who based his candidacy on restoring the soul of a nation buffeted by the pandemic and four years of domestic unrest.

"For a long time, we've reassured ourselves that American democracy is guaranteed," Biden said, speaking before a nationwide audience in Philadelphia with Independence Hall as his backdrop. "But it is not. We have to defend it. Protect it. Stand up for it. Each and every one of us.'

With little more than two months to go before this November's midterm elections, Biden drew a stark contrast between Democrats, independents, and "mainstream Republicans," who support and defend democratic norms, and "MAGA Republicans" who embrace political violence because they cannot accept that they'd lost an election.

"Too much of what is happening in our country today is not normal," Biden said. "[Former President] Donald Trump and MAGA Republicans represent an extremism that threatens the foundations of our democracy."

Biden's speech came even as Trump, who faces the very real prospect of a federal indictment over top secret documents found at his Florida residence, said he would not rule out pardons to Jan. 6 rioters who sacked the U.S. Capitol and violently attacked law enforcement officers if he regains the White House in 2024.

The optics of Biden's speech were hard to miss. More than two centuries ago, the Founders, with a bloody revolution barely in the rearview mirror, gathered in Philadelphia to hammer out the framework of a new nation.

Then, as now, the future was hardly assured. Then, as now, there were deliberate choices to be made about what kind of country the new United States of America would become.

What emerged was a nation forged in compromise, with branches of the government designed to counter and temper each other; a system designed to rein in the tyranny of both the majority and the minority. It was a breakthrough, but it was hardly perfect. It was then, and remains now, a work in progress. And it remains as fragile as ever.

Elections, they say, always are about choices. This year, at this point, those choices never have been more clear.

From book bans and efforts to restrict voting rights to the ahistorical insistence that America is a Christian nation (which condemns millions of our fellow citizens to secondand third-class status), these extremists and nationalists seek to turn back the clock on the "faith, freedom and reason," as the historian Jon Meacham describes it, that the Revolutionary Generation (as flawed as it was) fought so hard to usher into existence.

In these dark times, it's easy to give into cynicism, to dismiss Biden's speech as a political pep talk, given in a political season, that was designed to energize the base, and likely would not win him any new converts.

But as he exhorted Americans, in classic Biden fashion, to stand up, to get involved, and to "vote, vote, vote," it was hard not to feel a cautious optimism that his message would cut through the noise, and hit its intended mark, uniting the country in common purpose.

In his closing pitch, Biden made it clear he believes that's the case.

"There's nothing more important, nothing more sacred, nothing more American. That's our soul. That's who we truly are. And that's who we must always be. I have no doubt — none — that this is who we will be and that we'll come together as a nation. And we'll secure our democracy," Biden said, adding, "We just need to remember who we are."

Whether the passion behind Biden's plea will work only will be known on Election Day. But the gauntlet has been thrown down. An award-winning political journalist, John L. Micek is Editor-in-Chief of The Pennsylvania Capital-




