SIERRA MADRE POLICE **APPREHEND HIT AND RUN CYCLIST**

The Sierra Madre Police Department (SMPD) has apprehended a suspect in connection with a hit-and-run incident on February 3, 2024. The incident unfolded at approximately 10:03 am on N. Baldwin Avenue near Montecito Avenue, involving a collision between bicyclists and pedestrians. The collision inflicted significant injuries upon the pedestrian, and the bicyclist fled the scene. The Sierra Madre Fire Department transported the injured pedestrian to a local hospital.

In the aftermath of the incident, the SMPD Detective Bureau conducted an exhaustive investigation, culminating in identifying a suspect. The individual in question has been identified as 49-year-old John Gabriel, a resident of the City of Los Angeles.

On April 6, 2024, SMPD Detectives, in collaboration with patrol personnel, executed a search and arrest warrant at Gabriel's residence and storage unit in the City of Los Angeles. Pertinent evidence related to the hit-and-run incident was gathered during the operation. Consequently, John Ğabriel was taken into custody and booked for 20001(a) CVC - Hit and Run resulting in serious injury, a felony offense.

Gabriel is currently at the Pasadena Police Department jail, awaiting further legal proceedings. Formal charges are pending review by the Los Angeles County District Attorney's Office.

The victim of the incident is still recovering from her injuries.

The Sierra Madre Police Department remains steadfast in its commitment to ensuring the safety and well-being of all community members and will continue to diligently investigate incidents of this nature.

The SMPD urges individuals possessing information relevant to this collision or who may have witnessed the incident to step forward and contact Detective Nelson Ascano at (626) 355-1414 during business hours.

SMPD ASSIST FEDERAL **AGENTS IN ARREST OF A** SUSPECT AND SERVICE OF A SEARCH WARRANT

According to SMPD Captain Henry Amos, on Tuesday, April 9th, the Department of Homeland Security Investigations contacted SMPD to assist with the service of an arrest warrant and a search warrant at a home on E. Laurel Avenue in Sierra Madre.

Two SMPD officers accompanied the HSI Agents and the federal agency made an arrest and searched the premises.


The identity of the suspect has not yet been released.

HISTORY OF THE SIERRA MADRE FIRE DEPARTMENT

The history of the Sierra Madre Fire Department began over one century ago on the morning of January 21, 1921, when a raging fire broke out at the Sierra Madre Bakery and the closest responding unit was 30 minutes away. Once the fire was extinguished a conversation arose between the city and its residents for the essential need of a local fire agency. It was this incident that sparked the development of the Sierra Madre Volunteer Fire Department.

The community of Sierra Madre was served by committed individuals (many of whom worked and lived in the city) that volunteered their time to aid in fire suppression and medical emergencies. Included in the photo above is my husband's grandfather Roy Walsworth. My husband volunteered as well for over 20 years and we are proud to be part of this SMFD Family.

As time went on emergency medicine advanced, and of course Sierra Madre residents deserve the best service comparable to our neighbors and industry standards. In 2007 the residents of Sierra Madre elected to go from Basic Life Support (EMS) to a paramedic program (Advanced Life Support) This required the hiring of paramedic staff and other fire personnel to maintain the department. This was a huge increase in costs to the city and the UUT was implemented to support the Paramedic Program and further staffing costs for police personnel.

During the next 10 years the City struggled with staffing an all-volunteer department and slowly transitioned from a volunteer fire department to a combination of volunteer and paid personnel in 2011. By 2015 Sierra Madre could no longer adequately staff the fire department in order to respond to calls and the city then considered contracting the fire services to another entity such as Arcadia, maintaining our own department, or exploring various options. The residents of Sierra Madre made their wishes very clear to city officials that they wanted to maintain our own Sierra Madre Fire Department.

After many years of transitional and challenging times, the Sierra Madre Fire Department made the monumental change to a full-time career Fire Department on September 1, 2019. A full-time career department is a huge budget increase for the city and the department has been struggling to recruit and retain good, qualified people since they were earning 12-25% less than the comparable cities. To stop the continuous revolving door in both our police and fire departments, salary increases were applied to both departments in 2023 and we are now able to retain and recruit amazing men and women to our first responder family.

Sierra Madre is unique in that we are among the smallest cities in Los Angeles County at 3.5 square miles with approximately 11,000 population. We are also unique in that we are a full-service city with its own Police Department, Recreation and Community Services, Public Works, Sewer, Public Library and Fire Department.

Our public safety departments are excellent with excellent response times and highly qualified and trained personnel. We all want to live here because of the sense of community and safety in our city.

The current budget for the Fire Department is \$3.7M and the Police Department is \$6.3M. The city does not have the revenues to support the rising costs to maintain these departments. Residents of Sierra Madre and community leaders are putting forth a petition for circulation to place a ballot initiative on the November 2024 ballot. The Public Safety for Sierra Madre Measure will protect and preserve the public safety and emergency services of Sierra Madre. This will address the long-term problems generating approximately \$2.2M annually over the next 7 years.

The residents of the city have made their wishes very clear in that they want to continue to be a full-service city and maintain our police and fire departments. The city does not have the revenues to sustain the departments and without an additional revenue source this puts both departments in jeopardy.

Pasadena to Replace 110-year-old Water Main

Pasadena Water and Power (PWP) announced Thursday that they are replacing a 110-year-old water main along Bellefontaine Street as part of a major water infrastructure upgrade. The project will span from Pasadena Avenue to Fair Oaks Avenue along Bellefontaine Street.

According to PWP Acting General Manager David Construction has already begun and is expected to continue through June. The work will occur Monday through Friday, 9 a.m. to 4 p.m. he said.

To minimize impacts on area residents and businesses, construction efforts will be contained to approximately one block at a time. Temporary lane closures will happen during work hours, and traffic control signage and flagmen will assist motorists in navigating the area. When possible, at least one driving lane will remain accessible in both directions.

During construction, crews will use a variety of heavy equipment, including excavators, backhoes, loaders, and construction trucks, which may cause noise and dust in the area. Traffic signs and delineators will be used to minimize impacts on traffic flow along Bellefontaine St.

"PWP asks residents to observe and adhere to posted no parking zones,

posted no parking zones, construction signs, and watch for flagmen," Reyes said.

During the project, businesses and residents located on Bellefontaine St. between Pasadena Ave. and Fair Oaks Ave. may be impacted. Construction will intermittently affect water service. Notices of any water interruption will be given at least 48 hours in advance and special efforts will be taken to keep inconveniences to a minimum. After the new water main has been installed and placed into service, pavement and turf restoration will take place.



FIGHT THE BASTARDS!

From a jagged hilltop in Torres del Paine National Park in Chile, a group of hikers was marveling at the white tongue of a glacier descending through a valley to a vast blue lake. I asked our guide, a young Chilean woman from the capital city of Santiago, what it was like to live in this paradise near the tip of South America, and whether she kept up with the news from the outside world. "No, I stopped paying attention," she said with a laugh. "I don't even go back to Santiago much anymore," I said I couldn't blame her. While recently vacationing in a jurt in Patagonia, my wife, Karla, and I couldn't help but think about how nice it would be to escape the anger, violence and madness of the "civilized" world.

That fantasy, it seems, is widely shared. Exhausted and heartsick, many people are tuning out the grim news about politics, Gaza, Ukraine, and climate change, and musing with friends about where to flee.

Here's the problem with tuning out or running away, as temping as flight might be. Demagogues, dictators, and sociopaths are relentless in their pursuit of self-serving ends, and succeed when they wear down the resistance of principled people. When evil men triumph, escape is only temporary. While we were in Patagonia, we heard two sharp cracking sounds from the glacier-warning signs of the ancient ice's dramatic retreat and warming temperatures. Do nothing but admire the scenery, and one day the glaciers-and so much else-will be gone..The same is true of democracy and decency. We can succumb to doomerism and let the bastards win, or stand and fight for what matters, and for the world we leave our children and grandchildren. In the gloomiest depths of World Was 11, as Hitler's war machine rolled over Europe, "Winston Churchill had the inspiring rejoinder to despair: Whatever the cost may be, we shall fight. We shall never surrender."

P.S. The Nazis lost.


COUNTY OFFERS REWARD IN MONROVIA MURDER CASE

The Los Angeles County Board of Supervisors yesterday unanimously approved a motion introduced by Supervisor Kathryn Barger that extends a \$10,000 reward in exchange for information leading to the arrest of those responsible for the murder of 46 year-old Terry Al-ford. On Jan. 29, 2021, Mr. Alford was shot multiple times in front of a residence in Monrovia while visiting his family.

"Terry's life was violently and senselessly ended, leaving his wife, children, and loved ones grieving for the rest of their lives," said Supervisor Kathryn Barger. "His murder took place over three years ago but law enforcement agencies remain dedicated to finding those responsible for Terry's murder. I'm hopeful this \$10,000 reward encourages someone to step forward. Terry's family and the community at large deserve justice and closure."

According to law enforcement officials involved in the investigation, Mr. Alford was on a front porch when four male suspects approached the residence. At least two of the suspects shot him multiple times. Law enforcement investigators believe the shooting was gang related and intentional, but presume Mr. Alford was not the intended target.

WHY DO WE COLLECT SO MUCH TRASH?

Los Angeles residents were a bit stunned recently when a home in a wealthy neighbor-hood was shown to be many feet thick with trash. Apparently, the man who lived there would just toss his white trash bags into the yard, and he'd also bring things home that he thought he would This was apparently the result of several years of neglect, and neigh-bors said the smell was

terrible.

The situation was so bad with several feet of trash bags covering the entire property that the news media was called in, and finally Los Angeles Mayor Bass ordered the property cleaned up. Every one talked about the man who lived there, and whether he had a men-tal disorder. Without passing judgement on this man, I was visiting a client's home shortly thereafter. I was indoors in the large spacious and beautiful house. I realized then that there are different degrees of "mental disorder" when it comes to our penchant to collect stuff we don't need and will never use, and to pack it away wherever it will fit. Sometimes our amassed "stuff" is smelly and trashy, and sometimes it is exquisitely beautiful. Whatever the case, the collection of stuff way beyond any normal need is a mental disorder that af-flicts millions of Americans, yet it is rarely viewed in that light.

When I see rental storage units all over every city, it occurred to me that this is an out-growth of collecting and saving stuff. We have too much stuff, and we are willing to pay someone to keep our stuff, out of sight, out of mind.

Am I exaggerating? I know there are legitimate reasons to have a temporary storage unit, such as when you just sold a house and it is cheaper to store the furniture in one of these units than it is to store it in the house and keep paying the mortgage. But is that the norm? I learned that investment in storage units is by far the best form of real estate invest-ment. There is low turnover with long-term rentals. You never really deal with evictions and there are no plumbing issues, and few electrical issues. Investors know that people will continue to pay for the storage of their stuff -- stuff they already bought and paid for - as long as they can.

Those who are smart do some simple math and realize that after a few months, they could have purchased everything in the rental unit all over again, brand-new. But most do not do the math. It isn't until a few years have passed that renters grasp that there is little value in storing things that they are not actually using, which is why they are in stor-age. Once you have paid the price over and over again of everything in the storage unit, you start to realize that it's better to bail out, and simply get rid of all those great things that you thought you could not live without.

I'm not saying that you should just throw it all in the trash, though sometimes that's an option. Find a charity and donate as much as possible so that they can help needy peo-ple. And if the charity tells you that they do not want what you have, that should be telling you something very loud.

I believe in minimalism, going back to my early days of backpacking. I realized that I could live and live well with very little when I was in the mountains. I wanted to bring that same mentality back home to my life in the city. Though I probably collect as much junk as the average person, I have found that I have learned to discipline myself. 





The Derby Restaurant in Arcadia is part of a storied history like the racetrack that birthed it. As you shuffle through the restaurant you are taken back in time to an era when horseracing was the sport and Seabiscuit galloped through the Depression. Over the decades interest in the sport has waned with the divided attention of more channels than once could ever be envisioned. If you are a Hemingway fan, horseracing and boxing are as American as freedom. The great thing is



that you don't have to be a racing fan to enjoy this historic restaurant. The restaurant was made famous by its purchase in 1938 by Hall of Fame Horse Jockey George "The Iceman" Woolf, who rode Seabiscuit, and who wanted a place to gather his friends in the horse racing industry. He was famously known for his cool rides on horses. As other jockeys aggressively moved their mounts a fraction early, he patiently waited and finally unleash a well-timed run that would place his horse's nose on the winning end of the photo. Today the reins of the restaurant fall under the able hands of two young entrepreneurs who have maintained the identity of the restaurant.

There are many exciting items on the menu, and we started dinner with the World-Famous Cheese Bread. You know I love "World Famous" and it is enough bread to feed a cavalry. Our appetizer selection was the Crab Cakes and described on the menu as from the starting gate. I still like the one at the Frontrunner (at Santa Anita Racetrack) For my entree I went with the steak, a Bone-in Kansas City Rib Eye. Once the kitchen got the temperature right, it was so tender that I worked myself all the way into gnawing on the bone. My dinner companion ordered the Marinated Grilled Shrimp (aka Shrimp Skewers), breaking the rule of ordering seafood on a Sunday, but I gave it two thumbs up as well. As for desserts, there are many on the list, but for a special occasion I would go for the Baked Alaska. The Bar has Large screen TVs

INGREDIENTS:

- 1 pound uncooked pasta
- 1 tablespoon olive oil
- 2 cloves garlic, crushed
- 1/2 cup chopped red onion
- 1 pound skinless, boneless chicken breast meat cut into bite-size pieces
- 1 (14 ounce) can marinated artichoke hearts, drained and chopped
- 1 large tomato, chopped
- 1/2 cup crumbled feta cheese 3 tablespoons chopped fresh parsley
- 2 tablespoons lemon juice
- 2 teaspoons dried oregano
- salt and pepper to taste 2 lemons, wedged, for garnish

DIRECTIONS:

Bring a large pot of lightly salted water to a boil. Cook pasta in boiling water for 8 to 10 minutes, or until al dente; drain.

Meanwhile, heat olive oil in a large skillet over medium-high heat. Add garlic and onion, and saute for 2 minutes. Stir in the chicken. Cook, stirring occasionally, until chicken is no longer pink and the juices run clear, about 5 to 6 minutes.

Reduce heat to medium-low, and add the artichoke hearts, tomato, feta cheese, parsley, lemon juice, oregano and cooked pasta. Stir until heated through, about 2 to 3 minutes.

Remove from heat, season to taste with salt and pepper, and garnish with lemon wedges.

AntoLin Cellars is named after the owners - Tony and Linda Haralson. Tony is the winemaker while Linda handles the hospitality side. They have their own estate vineyard which produces Cabernet Sauvignon, Malbec, Carmenère and Riesling. The winery is located in Yakima Valley



HEALTHY TRAVEL TIPS FOR OLDER TRAVELERS

Dear Savvy Senior:

What tips can you offer retirees with health issues who are planning some trips? We've been looking forward to traveling again after staying home the past few years, but my husband has a heart condition and some back problems that worry me. Concerned Wife



Dear Concerned:

A dream vacation can turn into a real nightmare if you get ill or injured while you're away and aren't prepared. Before setting out, here are some tips to help ensure a safe and healthy trip for you and your husband.

Get prepared: Before you go, talk with your doctor about your travel itinerary and what precautions you need to take before traveling. You should also have your doctor's contact information with you when you travel, as well as a list of the medications you're taking in case you need emergency medical care while you're away.

It's also a smart idea to locate health clinics or urgent care facilities near the areas you're visiting. Your hotel can help you with this or a simple internet search can identify nearby health care services. If you're traveling abroad, the U.S. consulate or embassy in the countries you're visiting (go to step.state.gov to enroll your trip) is a good place to get a referral. Or use the International Society of Travel Medicine's directory at ISTM.org.

If you're traveling outside the U.S., you also need to find out the health conditions of the country you're visiting and what, if any, vaccinations and/or preventative medications are recommended. See CDC.gov/travel or call 800-232-4636 to get this information.

Check your insurance: If you have private health insurance or a Medicare Advantage plan through an HMO or PPO that covers in-network doctors only, check your plan to find out what's covered if you need medical care when traveling outside your geographic area.

Beneficiaries that have original Medicare are covered everywhere in the U.S. But if you're traveling abroad, you won't be covered outside the U.S. and its territories except in rare circumstances, although some Medicare Advantage plans and some Medigap supplemental policies do provide limited coverage. Most private health plans don't pay health care costs outside the U.S. either. Be sure to check.

Many retirees traveling abroad purchase travel insurance with medical coverage, which may cover expenses if you cancel the trip, need to be treated while traveling or need to be evacuated for medical care. Make sure the policy will also cover your preexisting medical conditions. To shop and compare policies visit TravelInsurance.com, InsureMyTrip.com or SquareMouth.com.

Organize your medications: Make sure you have a sufficient supply of medications to last the entire

If traveling by air, you need to pack your medicine in your carry-on bag, so if your checked luggage gets lost or misdirected you won't be without. It's best to keep your medications in their original containers to get through airport security without delays. It's also a good idea to bring along a note from your doctor that explains why you take these medications, especially if syringes or other medical supplies are involved.

For airport security requirements visit TSA.gov - click on "Disabilities and Medical Conditions." You can also call TSA Cares at 855-787-2227 prior to traveling with questions about screening policies, procedures and what to expect at the security checkpoint.

Maximize technology: Keep a list of your medications and other important health and medical information handy on your smartphone so you can easily access and share it with emergency health care providers when you're traveling. Some good apps that can help with this are Backpack Health (BackpackHealth.com) and Capzule (Capzule.com).



Many tasty foods are born in the South And none of them stick to the roof of your mouth Colonel Sanders would agree if only he could Peanut butter toast is finger lickin' good




