CITY SEEKS DAMAGES FROM SOUTHERN CALIFORNIA EDISON **OVER EATON FIRE DESTRUCTION**

(Sierra Madre) The City of Sierra Madre initiated legal proceedings today against Southern California Edison for damages to public lands, trail systems, and infrastructure caused by the January 2025 Eaton Fire.

"The January fire devastated irreplaceable wilderness areas that are central to Sierra Madre's identity and character," stated Mayor Robert Parkhurst. "Our historic wilderness areas and the Mount Wilson Trail - treasured community resources that draw visitors from across Southern California - now require extensive rehabilitation that will burden our city for years to come."

The litigation follows Edison's February 6 disclosure to the California Public Utilities Commission admitting that a "fault was detected" on its Eagle Rock-Gould transmission circuit coinciding with the fire's ignition time and location. Video and photographic evidence show flames erupting near the base of Edison transmission towers in Eaton Canyon moments after electrical anomalies were recorded.

Damage sustained by Sierra Madre includes:

- Severe ecological harm to the Sierra Madre Historical Wilderness Area
- Destruction of significant portions of the historic Mount Wilson Trail network
- Heightened vulnerability to post-fire mudslides requiring immediate mitigation
- Damage to municipal infrastructure including roads and water systems

The lawsuit contends that despite explicit warnings from the National Weather Service about extreme fire danger and winds forecasted to reach 100 mph in the foothills, Edison failed to adequately de-energize its equipment in high-risk

"What makes this disaster particularly troubling is its preventability," Mayor Robert Parkhurst added. "The documented weather warnings provided Edison with ample notice of the dangerous conditions developing in our com-

The legal action includes eight causes of action ranging from inverse condemnation to violations of Public Utilities and Health & Safety codes. In addition to compensation for direct damages, the city seeks recovery of fire suppression costs, ongoing expenses for restoration of natural resources, and funds to address heightened flood and debris flow risks resulting from the fire's destruction of hillside vegetation.

The January 7th Eaton Fire ultimately consumed more than 14,000 acres, destroyed approximately 9,400 structures throughout the region, and claimed 17 lives. Los Angeles County and the City of Pasadena also filed lawsuits against Edison today.

The City of Sierra Madre is represented by City Attorney Aleks Giragosian of Colantuono, Highsmith & Whatley, P.C., with additional representation from outside counsel John Fiske, Torri Sherlin, and Taylor O'Neal of Baron & Budd P.C., and Ed Diab, Rob Chambers, and Kristen Barton of Diab Chambers LLP, the same legal team supporting Los Angeles County and Pasadena in its related litigation.

CODE ENFORCEMENT OFFICERS TO WEAR BODY CAMS By Kevin McGuire/MVNews

Code Enforcement Officers in Sierra | may also reduce civil liability to the Madre will now be required to wear body-worn cameras after the City Council adopted the policy during their regular meeting on Tuesday, February 25, 2025.

Code Enforcement Officers enforce municipal codes in the city and investigate violations as directed by the City Manager. These codes include building and zoning codes. Code Enforcement Officers aim to serve the public by improving the residents' quality of life by reporting health and safety risks.

Across the county, police departments and other municipalities are increasingly using body-worn cameras ("BWC") to effectively monitor and record enforcement interactions with the public by governmental employees. The SMPD has issued BWCs to each of its police personnel responsible for enforcement efforts. These recordings have been instrumental in accurately recording public interactions and enforcement actions. These recordings

City, according to City Attorney Aleks Giragosian's agenda report presented before the City Council.

Giragosian explained why he feels BWC would benefit Code Enforcement Officers. "It's happened more than once; our Code Enforcement Officer spots construction at a site, goes to that site, and tells the workers they need to stop work. The property owner will come and get in a fight with our Code Enforcement Officer and then lodge a complaint against the city." Giragosian followed up by saying it turns into a "he said, she said" situation, and no one knows what actually transpired. "It makes processing these cases more difficult," Giragosian said.

The city consulted with the Sierra Madre Police Department to determine which body-worn cameras would be the best option for Code Enforcement Officers. Axon BWC was recommended, and two have been purchased so far.

BWC Policies and Procedures were created as guidelines, and instructions were provided to Code Enforcement Officers to teach them how to use the cameras and accurately record interactions with the community. This ensures residents are treated fairly regarding officers enforcing the city's codes. The hope is that BWC will create transparency, limit civil liability, and enhance professionalism, according to the report.

There are five procedures when Code Enforcement Officers use BWCs.

Non-Ĉode Enforcement Activity

Code Enforcement Activity on Public Property

Code Enforcement Activity on Private Property Fully Exposed to Public View

Code Enforcement Activity on Private Commercial Property Fully Exposed to Public View

Code Enforcement Activity on Private Property Not in Public View.

Under Penal Code section 832.18, these BWC policies comply with state law and procedures and will ensure Code Enforcement Officers do not violate residents' right to privacy. Residents can refuse to be recorded, and the officer will turn off their BWC.

Any recordings of an enforcement action shall be maintained in a cloud-based third-party server provided through a contracted license agreement through Evidence.com. These recordings shall be saved for various timeframes depending on the nature of the interaction and/or the enforcement action. Recorded encounters will provide an objective/transparent review by staff or involved parties following an encounter resulting in an enforcement action. Recordings may also be used as physical evidence to document what transpired during the issuance of a citation or support investigations resulting in municipal code violations that have financial implications and potential for an administrative review or subsequent appeal hearing.

The body-worn cameras will be activated before officers enter a property or business. They may not turn off BWCs until their interaction with the public has ended. At the end of their shift, the officers will upload the recordings to the cloud service.

Code Enforcement Officers may not record:

personal, telephone, or video conversations without the other participant's knowledge.

Any footage where there is a commonly held expectation of privacy, such as restrooms,

dressing rooms, or locker rooms. Non-work-related activity.

Councilmember Kelly Kriebs and Mayor Pro Tem Kristine Lowe expressed the importance of transparency when enforcing laws and interacting with the public. "It builds trust with our city and staff and our public that we're transparent," Lowe said.

Sierra Madre Police Chief Gustavo Barrientos echoed these sentiments. "The BWCs are an extra layer of accountability and transparency which builds on public trust," Barrientos said.

However, a few Council members expressed privacy concerns about the policies and procedures. "I'm still struggling with this personally," Council Member Edward Garcia stated. "There's not an expectation of someone coming on a worksite that they are going to be recorded, a resident or anybody." Garcia felt there was a need for some announcement from Code Enforcement Officers alerting the public that they would be recording the interaction with the public.

"I think people have the right to privacy," Council Member Gene Goss said. After some healthy debate on the topic, all Council Members agreed that Code Enforcement Officers can record from in front of the properties (public sidewalk, street) but need permission from the residents to continue recording as they enter the private property.

Mayor Robert Parkhurst agreed to the added language. He called on the City Council to reevaluate in 90 days to see how the new BWC Policies and Procedures work out for Code Enforcement Officers and the public.

Our Response to the Eaton Fire

The San Gabriel Valley Mosquito and Vector Control District is committed to supporting residents affected by the Eaton Fire. As part of the recovery efforts, we are working to prevent unmaintained swimming pools and large sources of standing water from becoming mosquito sources, which can spread diseases like West Nile virus and St. Louis encephalitis.

Unmaintained pools pose a high public health risk. A single pool can produce up to 3 million mosquitoes in just one month. These mosquitoes can spread quickly throughout the community, putting residents at risk. Our team is actively providing resources and treatment options to help prevent mosquitoes from growing during the recovery phase.

Additionally, in recognition of the hardship faced by property owners in the Eaton Burn Area, the District's Board of Trustees has authorized participation in Los Angeles County's Direct Assessment Disaster Relief Program. Under this program, administered by the Los Angeles County Property Tax Services Division, the County will:

Remove SGVMVCD direct assessment charges for Fiscal Year (FY) 2024-2025 on affected parcels.

Issue refunds to taxpayers who have already made direct assessment payments for FY 24-25.

Provide ongoing updates regarding additional affected parcels as property damage assessments continue.

The District's benefit assessment is \$20 per parcel per year. Property owners do not need to take any action to receive this relief—eligible parcels will automatically have direct assessment charges removed, and refunds will be processed by the County for payments already made.

What Property Owners Need To Do

If you are a property owner in the Eaton Burn Area, we need your cooperation to prevent mosquitoes from growing. Standing water that supports mosquito production is considered a public nuisance according to the California Health and Safety Code (§§ 2060-2061), and property owners are responsible for abating such conditions.

Please complete the following steps:

Step 1: Request for Mosquito Control Services

This is the first step in coordinating efforts to ensure pools and other large water sources are addressed promptly. While the form is not required for property access, the District is collecting forms as a FEMA requirement for work conducted as part of disaster response efforts.

Step 2: Enroll in SGVpools - Eaton Response

The District's SGVpools program was created to facilitate communication between property owners and the district regarding the status of pools. By enrolling into the District's Virtual Swimming Pool program, it allows the District to monitor the status of your pool throughout the recovery phase.

Only two conditions will guarantee that mosquitoes do not grow: "Clean and Functional" or "Empty and Dry." However, we understand that the recent fires have brought a significant loss and disruption to your life, and there is no clear path to when the pool can be brought to either state. The district may provide resources and long-term treatments depending on the status of your pool.

HUD Extends Foreclosure Relief to Californians Impacted by Los Angeles County Wildfires

HUD Secretary Scott Turner announces 90-day extension of foreclosure moratorium on Federal Housing Administration (FHA) single family mortgages in impacted areas. Altadena, Calif. - Today, the U.S. Department of Housing and Urban Development (HUD) is an-

nouncing a 90-day extension of its foreclosure moratorium on Federal Housing Administration (FHA)-insured single family mortgages in the areas of Los An-geles County, California, devastated by

HUD Secretary Scott Turner is making this announcement while touring a disaster zone in Altadena with Fifth District of Los Angeles Supervisor Kathryn Barger. The FHA-insured single family mortgage extension underscores HUD's commitment to supporting Americans impacted by natural disasters by providing flexibility to families in the Presidentially Declared Major Disaster Area (PDMDA). There are over 100,000 FHA-insured mortgages in Los Angeles County PDMDA. HUD is working with mortgage servicers and others to assess the extent of properties with FHA-insured mortgages in the designated area that have been severely damaged or destroyed.

"It is heartbreaking to witness the devastation caused by the horrific wildfires in Altade-na and the surrounding areas of Los Angeles County and the heavy toll of this tragedy on individuals, families and communities," said Secretary Scott Turner. "Empowering and supporting our neighbors so they can build or rebuild their future, including when disaster strikes, is a core part of HUD's mission and we will continue providing help during hardship."

"HUD's extension of the foreclosure moratorium is a lifeline for wildfire survivors in Los Angeles County who are facing immense hardship," said Los Angeles County Su-pervisor Kathryn Barger. "I appreciate Secretary Turner's leadership and commitment to ensuring that families impacted by these devastating fires have the time and support they need to recover. This critical relief will help stabilize our communities as we work together to rebuild and heal."

The moratorium prohibits mortgage servicers from initiating or completing foreclosure actions on FHA-insured single family forward or Home Equity Conversion mortgages in the Los Angeles County PDMDA through July 7, 2025. The moratorium was original-ly set to expire on April 8, 2025.

- Borrowers unable to make their mortgage payments should contact their mort-gage servicer for assistance as soon as practical. Borrowers may also contact the FHA Resource Center at (800) CALL-FHA (1-800-877-8339; or for TTY 1-800-877-8339) for assistance.
- For borrowers and renters who need immediate housing and disaster recovery assistance, HUD-certified housing counselors are prepared to provide guidance on the options that are available. To find a HUD-approved housing counseling agency, borrowers can use HUD's online search tool or use our phone search by calling (800) 569-4287 or (202) 708-1455 (TTY).
- For borrowers whose homes are destroyed or damaged to an extent that requires reconstruction or complete replacement, contact an FHA-approved lend-er about FHA's Section 203(h) loan program. This program provides 100 percent financing for eligible homeowners to rebuild their home
- For borrowers seeking to purchase and/or repair a home that has been dam-aged, contact an FHA-approved lender about FHA's Section 203(k) loan pro-gram. This program allows individuals to finance the purchase or refinance of a house, as well as the costs of repair or renovation, through a single mortgage.



29TH ANNUAL BUTTERFLY SEASON EMERGES ON MARCH 13th AT KIDSPACE CHILDREN'S MUSEUM

PASADENA, CA (March 6, 2025) Kidspace Museum announces the joyful return of its annual Butterfly Sea-son, beginning March 13. This vibrant celebration of butterflies, pollinators, and the natural world is more meaningful than ever, offering an opportunity for the community to reconnect with nature and experience the wonder of renewal.



The crowd? Yelp reviews often mention it's a cop hangout, and you know what? That's fine by me. A steady stream of locals, workers, and longtime fans come through, proving that Eastside Market Deli has been do-ing something right for decades. I wouldn't be surprised if Tommy Lasorda snuck over here a few times.

Yes, prices have gone up—what hasn't? But the portions remain generous, and the quality is still solid.

INGREDIENTS

- 1 sheet refrigerated pie crust
- 3/4 cup sugar
- 2 tablespoons cornstarch 1 cup water
- 1 package (3 ounces) strawberry gelatin
- 4 cups sliced fresh strawberries
- Real Whipped Cream, Pastry Topping or Cool Whip, optional

DIRECTIONS

Preheat oven to 450°. Unroll crust into a 9-in. pie plate. Trim edge. Line unpricked crust with a double thickness of heavy-duty foil or parchment. Bake 8 minutes. Remove foil; bake 5 minutes longer. Cool on a wire rack.

In a small saucepan, combine the sugar, cornstarch and water until smooth. Bring to a boil; cook and stir until thickened, about 2 minutes. Remove from the heat; stir in gelatin until dissolved. Refrigerate until slightly cooled, 15-20 minutes.

Meanwhile, arrange strawberries in the crust. Pour gelatin mixture over berries. Refrigerate until set. If desired, serve with whipped cream.

Mourvedre is a GSV blend - 65% Grenache, 30% Syrah, and 5% Viognier. Just like last week's wine, the grapes are sourced from the organically farmed Shake Ridge Ranch in Amador County. It spent 21 months in neutral French oak. It's got dark fruit notes along with pencil shavings, floral, and spice notes. It's got enough minerality to give you a superbly balanced wine. It's drinking extremely well right now. Only 146 cases were produced.

Cantadora Wines was founded in 2021 by Kira Ballotta to spotlight the stories of extraordinary women giving back in novel and profound ways to our shared community.

HOMELESSNESS

Homelessness is a large and growing problem in L.A. County. If you happen to be homeless, it's not a "problem," it's a personal crisis. Among other things, the insane cost of housing is a factor in the increase in homelessness, though not the only cause.

Perhaps I feel real empathy for the homeless because I know what it's like to be adrift in the urban sea with no house or home. I was homeless for about 6 months in 1984, an experience that I wrote about extensively at that time. I know that with deter-mination, and with the help of loving friends, it is possible to overcome this very real threat to survival.

I was once asked during a radio interview what advice I'd give to someone who was homeless. My response: I would first take the time with the homeless person in or-der to determine precisely how they become homeless. We would look at each point by uncomfortable point in order to see how their thinking, their actions, their inactions, led to homelessness so we could chart a path to changing those habits. Determining the cause is of paramount importance, since each and every homeless case is unique.

It has been well-demonstrated there is no actual physical shortage of places for people to live, even in the big cities. In fact, especially in the big cities.

The problem is complex, but we can state that homelessness is the result of one or more of the following: rapidly rising cost of living, unemployment, psychological problems, drug and alcohol use, and maybe "other." If you are an alcoholic or a drug user, you need to do whatever is possible to stop those habits. Period. The alcohol and the drug use is a threat to your basic physical survival.

The solution to homelessness involves the cooperation of local community or-ganizations, and the homeless individuals themselves.

Though there is no shortage of people willing to assist, never forget that "assistance" is a two-way street.

Mark Holsinger, Executive Director of the Los Angeles Mission, wrote a "Letter to the Editor" in the March 14, 1992 Los Angeles Times. He said, "As frustrating as it is that not all homeless people accept help, we should not forget that many gratefully ac-cept the opportunity to change their lives. The problem for most of the homeless isn't a lack of services or affordable housing or jobs. Their problem is their lack of desire to change [emphasis mine] -- to get off drugs, to function in a way that is acceptable to society, to respect others and themselves." He adds that it's not easy to get off the streets, but certainly possible to become a productive citizen because he works daily with those who've made that change."

Let's assume you have lost your home, you have no job, and you aspire to get back to work and find a home. What do you do? Where do you start?

Number one: If you are taking drugs, or drinking alcohol, stop! If you know you cannot stop without help, do whatever it takes to get that help.

Number two: Do whatever it takes to change your attitude. Quit viewing yourself as a victim of circumstances. Quit blaming anyone else. Quit feeling negative towards anyone.

Next, wherever you are, improve it. Make it better. If you are with others, teach by your example. If they ask what you are doing, explain to them that you are practicing the uplifting Principle of "making every place better for my being there." This is known as true Appreciation.

Also, do not steal or take that which is not yours, regardless of your "very good justification."

Begin to give to the charity, non-profit, or church of your choice." Giving can al-so be of your time. Give without the expectation of "getting" anything back. Don't give foolishly, but give intelligently to help further the work of a charity. The principle at work is "As ye give, so shall ye receive."

As you practice these simply principles – which some people will ridicule as "simplistic"

This, of course, is just the very bare-bones beginning. Part of the solution also involves caring people, and the assistance of the City of Los Angeles, and local non-profits.

The solution also includes realistic employment training, and financial education, such as how to budget your money, and how to determine (Thoreau-style) how to differentiate "want" from "need." I have met SO many folks who have lost their homes, even though they continued to use a credit card to buy stuff they didn't need, and continued to use credit even as they could barely make the minimum payments.

I intend to address each of these related topics in future columns, and I welcome your comments and questions.





HOW TO REPLACE IMPORTANT LOST DOCUMENTS



Dear Savvy Senior,

How do I go about replacing some important documents that were lost when our home of 50 years burned down? We lost everything including our house deed, car titles, old tax returns, Social Security and Medicare cards, birth certificates, marriage license and passports. Suffering in SoCal

Dear Suffering,

I'm very sorry to hear about the loss of your home, but you'll be pleased to know that replacing most of the lost documents you mentioned is pretty easy once you know where to turn. Here are the resources to help you get started.

Birth certificates: If you were born in the United States, contact the vital records office in the state where you were born (see CDC.gov/nchs/w2w/index.htm for contact information). This office will give you specific instructions on what you need to do to order a certified copy and what it will cost you – usually between \$10 and \$30.

Car titles: Most states offer replacements through a local department of motor vehicles office. You'll need to complete a replacement title application form and pay the application fee, which varies by state. You'll also need to show ID and proof that you own the car, such as your vehicle registration or your license-plate number and VIN (vehicle identification number).

Property deed: To access your house deed, contact your county clerk's office, where deeds are usually recorded. You may be charged a small fee to get a copy.

Marriage certificate: Contact the vital records office of the state you were married in to order a copy (see CDC.gov/nchs/w2w/index.htm). You'll need to provide full names for you and your spouse, the date of your wedding, and the city or town where the wedding was performed. Fees range from

Social Security cards: In most states, you can request a replacement Social Security card online for free at SSA.gov/myaccount. When you get there, click on "Replace your Social Security Card" and answer a few questions to verify your identity.

Medicare cards: If you're enrolled in original Medicare, you can replace a lost or damaged Medicare card by calling Medicare at 800-633-4227, or by logging into your MyMedicare.gov account, where you can print or request a new card to be mailed to you for free. If you're enrolled in a Medicare Advantage Plan, such as an HMO, PPO, or PDP, you'll need to call your plan to get your card replaced. And, if you get Railroad Retirement Board benefits, you can get a replacement card by calling 877-772-5772.

Tax returns: To get copies of old tax returns start with your tax preparer, who usually keeps copies of your returns on file. You can also get copies of federal returns directly from the Internal Revenue Service. You'll need to fill out and mail in IRS form 4506. To download this form IRS.gov/pub/irspdf/f4506.pdf or call 800-829-3676 and ask them to mail you a copy. The cost is \$30 for each return requested.

And to get copies of your state tax returns, contact your state's department of revenue who will also require a request form. See TaxAdmin.org/fta-members for state contact information.

Passports: If your U.S. passports were valid, you'll need to first report them as lost or stolen so they can be canceled. You can do this online at PPTform.state.gov or in person when you apply for a new passport at a Passport Application Acceptance Facility, which are located in many U.S. post offices. See iafdb.travel.state.gov to locate one near you. You'll also need to submit Form DS-64 and Form DS-11. The replacement fee is \$130 per passport.





As to what went on at that Oval | lent pig" Zelensky. Office meeting between Trump and Zelensky, Susan Rice, former U.N. Ambassador and National Security Advisor under President Obama, told CNN that "it was a setup" – establishing pretext for Trump suspending aid to Ukraine as Russian President Putin wanted. The aid was suspended three days after the meeting.

Trump had demanded \$500 billion of Ukraine's "rare earth" materials as payback for what he claimed was \$350 billion in aid already given. (It's actually around \$124 billion.) Zelensky came ready to make a deal. All he'd want in return would be security guarantees - expecting Putin to use whatever pause in fighting to rebuild his forces for further attacks.

These things are usually hammered out in private – with press called in later for announcement of agreement, or of "frank discussion" to be continued later. But here, as Ambassador Rice explained, "Donald Trump kept the pool spray in there for 40 minutes, and was saying things that were outrageous like . . . Ukraine started the war and Russia is not the aggressor."

She said Trump "gave the permission to J.D. Vance in advance to try to provoke Zelensky . . . to start a rumble that would have two purposes. One, to appeal to Trump's base . . . they've been sending all of their lackeys out to tout how wonderful it was, when in fact it was a massive embarrassment for the United States of America. But the other audience was Vladimir Putin."

While Reuters and the AP were barred from the room, Russian state media were present although, according to the White House, they were "not on the approved list" (just somehow managed to sneak into the Oval Office). Russian media has since made ample use of that

Ambassador Rice summarized, "This was a setup designed to humiliate and antagonize the Ukrainians and Zelensky . . . Trump is aligning the United States of America with Vladimir Putin and, by extension, his best buddies, China, North Korea, and İran, and abandoning our NATO allies, abandoning Ukraine, abandoning our principles, our values and democracy. It's dangerous and shameful."

Thirty years ago, Trump relied on Russian oligarchs to bail him out from his failed casinos - American banks had had enough of him. Then came talk of Trump Towers in Moscow. Trump seems enamored by Putin's brand of authoritarianism; critics imprisoned, poisoned or falling from high-rise windows – with power held for as long as he wants.

Putin knows how to deal with Trump; his former national security advisor Lt. Gen. H.R. McMaster says he's "being played". Sen. Chris Murphy (D-CT) sees the administration as "becoming an arm of the Kremlin" (if it isn't already).

Senator (retired Air Force Brig Gen) Don Bacon (R-NE) called the session "A bad day for America's foreign policy. Ukraine wants independence, free markets and rule of law. It wants to be part of the West. Russia hates us and our Western values. We should be clear that we stand for freedom." Shortly after Russia launched its invasion, Trump was calling those giving aid to Ukraine

Former Rep. (and Air Force vet) Denver Riggleman (R-VA) says, "The enemy is on the inside." Rather than having leaders "who care more about this country than coverage to praise Trump's "proper slap down" of "inso- | securing mineral rights for their oligarch friends", now

"They're specifically trying to make Putin happy."

Following that Oval Office meeting, Pradheep Shanker wrote for National Review, "Countries around the world now understand that the USA isn't someone you can depend on when the going gets tough. Trump is weak, and that is what he portrayed today". Adds former George W. Bush speechwriter David Frum, "It exposed in the most undeniable, unequivocal way possible the pro-Putin commitments of the president and vice president. That was information Americans and allies needed to have clear before them."

Immediately after leaving Washington, Zelensky flew to London to meet with PM Starmer, who with other European leaders made clear their commitment to Ukraine (excepting Orban of Hungary). Zelensky made clear Ukraine's position: a ceasefire, security guarantees, exchange of prisoners and return of some 20,000 kidnapped children.

Also clear, after eighty years of the U.S. President being regarded as "leader of the free world", was EU foreign policy chief Kaja Kallas' statement that now "the free world needs a new leader". After only a few weeks of Trump in office, the U.S. can no longer be regarded as a serious partner - let alone as that "indispensable nation".



BEYOND STRENGTH: THE TENDER SIDE OF HARRIET TUBMAN

As we celebrate Women's History Month and Harriet Tubman Day on March 10th, let's reflect on how we remember this American icon. Most of us know her as the fearless conductor of the Underground Railroad — her stern face staring back at us from those few surviving photographs, embodying strength and determination.

Author Jason Reynolds once described her face as "incapable of smiling." However, those photographs reflect the limitations of 19th-century technology — requiring subjects to remain still for several minutes — rather than Tubman's emotional range. Perhaps in focusing solely on her extraordinary courage, we've fallen into the "strong Black woman" stereo-

type, missing the fullness of her humanity.

I was struck by artist Kerry James Marshall's painting "Still Life with Wedding Portrait," which imagines Tubman as a young bride. This tender depiction resonates with Ann Petry's biography, "Harriet Tubman, Conductor of the Underground Railroad," which describes how Harriet dreamed of marrying John Tubman, a free man. She loved his laugh and lilting whistle. She even sewed a patchwork quilt by hand for her wedding trousseau.

Marrying John made her very happy, and she wanted to be free.

She wanted both.

Though John never supported her freedom dream — even threatening to report her if she tried to escape Harriet left anyway, carrying her treasured quilt. That same quilt became instrumental in her escape when she gifted it to the woman who helped her on the first leg of her journey.

Because she truly loved him, she returned for John, only to be laughed at — that same laugh she once adored now becoming a source of pain. Undeterred, she channeled her energy into her mission, returning south repeatedly to guide others to freedom, including her family members who faced being sold "down the river" and, eventually, her elderly parents.

Through it all, that desire for love and tenderness never left her.

As we navigate today's challenging political landscape, Tubman's example reminds us that we can be both strong and tender. We don't have to choose. Honoring our whole selves — including our need for rest, joy, and connection — makes us more effective in our commitments to community.

This is especially true for helpers and community leaders, who often put others' needs before their own. We must remember to:

Look for moments of awe and wonder. We need to put our shields down sometimes. Notice what's good in our lives and celebrate it. Reject either-or thinking and embrace both/and.

In these times that feel divisive and difficult, these practices aren't luxuries — they're necessities that sustain our ability to serve and create change. Harriet Tubman's legacy teaches us that profound courage can coexist with deep tenderness. Her example invites us to honor all aspects of ourselves as we work toward a more just world.

NONDUALITY & THE NATURE OF OUR EXISTENCE

Nondualism emphasizes direct experience as a path to understanding. While intellectual comprehension has its place, nondualism emphasizes the transformative power of firsthand encounters with the underlying unity of existence. Through practices like meditation and self-inquiry, practitioners aim to bypass the limitations of conceptual understanding and directly apprehend the interconnectedness that transcends superficial distinctions. This experiential aspect of nondualism challenges the limitations of language and rational thought, siming for a more immediate intuitive form of knowledge. aiming for a more immediate, intuitive form of knowledge.

Each nondual tradition presents unique interpretations of nonduality. Advaita Vedanta, a school of thought within Hindu philosophy, focuses on the realization of the unity between the individual self (Ātman) and the ultimate reality (Brahman). In Zen Buddhism, the emphasis is on the direct experience of interconnectedness that goes beyond conventional thought constructs. Dzogchen, found in Tibetan Buddhism, highlights the recognition of an innate nature free from dualistic limitations. Taoism embodies nondualism by emphasizing the harmony and interconnectedness of all phenomena, transcending dualistic distinctions, towards a pure state of awareness free of conceptualizations.

People regard themselves as separate units, separate from the world and from other people. Only after removing the veil that the mind creates you will be able to realize the Oneness of everything and, thereby, realize what nonduality is. Oneness is right here, right now!


